Chapter 63

RESOLVE, in Favor of Claude Boyington, of Prentiss.

Claude Boyington; compensated. Resolved: That there be, and hereby is, appropriated from the general highway fund the sum of \$62.50 to be paid to Claude Boyington of Prentiss for work done on a State Aid Highway, as a full and final settlement of his claim against the State.

Chapter 64

RESOLVE, Closing Spring Pond in Piscataquis County to Fishing Except Fly Fishing.

Spring Pond closed to all fishing except fly fishing. Resolved: That the Commissioner of Inland Fisheries and Game be and hereby is authorized and directed to issue a rule and regulation closing Spring Pond in T 7, R. 10, Piscataquis County, to all fishing except fly fishing and establishing a day limit of 5 fish.

Chapter 65

RESOLVE, Regulating Fishing in Kewayden Lake and Virginia Lake in Oxford County.

Fishing in Kewayden Lake and Virginia Lake; regulated. Resolved: That the Commissioner of Inland Fisheries and Game be, and hereby is, authorized and directed to issue a rule and regulation to remove all size and bag limits on white perch in Kewayden Lake and Virginia Lake, Oxford County. The open season to conform with the general law ice fishing and open water fishing seasons in all waters.

Effective August 20, 1955

Chapter 66

RESOLVE, Regulating Fishing in Rattlesnake (Pequawket) Pond, Oxford County.

Fishing in Rattlesnake (Pequawket) Pond; regulated. Resolved: That the Commissioner of Inland Fisheries and Game be, and hereby is, authorized and directed to issue a rule and regulation to remove all size and bag limits on white perch and pickerel in Rattlesnake (Pequawket) Pond, in the county of Oxford. The open season to conform with the general law, ice fishing and open water fishing seasons in all waters.
