## Chapter 67

### RESOLVE, Regulating Fishing in Cobbosseecontee Stream in Kennebec County.

Fishing in Cobbosseecontee Stream; regulated. Resolved: That the Commissioner of Inland Fisheries and Game be, and hereby is, authorized and directed to issue a rule and regulation opening Cobbosseecontee Stream in Gardiner, West Gardiner, Manchester and Litchfield, in Kennebec County, to all fishing from April 1 to September 30.

## Chapter 68

### RESOLVE, in Favor of Kathryn C. Douglas of Augusta.

Kathryn C. Douglas; compensated. Resolved: That there be, and hereby is, appropriated the sum of \$1,458 from the General Highway Fund to be paid to Kathryn C. Douglas, of Augusta, as a full and final settlement of her claim against the state, to compensate her for injury received while working for the Motor Vehicle Department.

## Chapter 69

### RESOLVE, Regulating Fishing in Second Gardner's Lake in Marion Township, Washington County.

Fishing in Second Gardner's Lake, Marion Township, regulated. Resolved: That the Commissioner of Inland Fisheries and Game be, and hereby is, authorized and directed to issue a rule and regulation opening to ice fishing, for all fish except trout and salmon, Second Gardner's Lake in Marion Township, Washington County, from the time ice forms in the Fall until it goes out in the Spring.

## Chapter 70

### RESOLVE, Regulating Fishing in Johnson Pond in Knox County.

Fishing in Johnson Pond; regulated. Resolved: That the Commissioner of Inland Fisheries and Game be, and hereby is, authorized and directed to issue a rule and regulation opening Johnson Pond, Appleton, Knox County, to ice fishing.

Effective August 20, 1955
