Chapter 78

RESOLVE, Regulating Fishing for White Perch in Certain Counties and Waters.

White perch fishing in certain waters regulated. Resolved: That the Commissioner of Inland Fisheries and Game be, and hereby is, authorized and directed to issue the following rules and regulations:

1. To remove all size and bag limits on white perch in Androscoggin County, and to make the open season conform with the general law ice fishing and open water fishing seasons in all waters.
2. To provide that there shall be no size or bag limits on white perch in any of the waters of the county of Hancock, and that the fishing season for white perch in the aforementioned waters be made concurrent with that in existence for salmon and trout, and that any lures or gear legal for the taking of salmon and trout be legal for the taking of white perch.
3. To provide that there shall be no bag limit or size limit on white perch taken in Annabessacook Lake in the towns of Monmouth and Winthrop, County of Kennebec.
4. To provide that there shall be no bag limit or size limit on white perch taken in Cobbosseecontee Lake in the towns of Litchfield, Monmouth and Winthrop, County of Kennebec.
5. To provide that there shall be no size or bag limits on white perch taken in Cochnewagon Pond in the town of Monmouth, County of Kennebec.
6. To provide that there shall be no bag limit or size limit on white perch taken in Maranacook Lake in the town of Winthrop and Readfield, County of Kennebec.
7. To provide that there shall be no bag limit or size limit on white perch taken in Wilson Pond in the towns of Monmouth and Winthrop, County of Kennebec.
8. To remove all size and bag limits on white perch in Knox County, and to make the open season conform with the general law ice fishing and open water fishing seasons in all waters.
9. To open Unity Pond, Waldo County, to fishing for white perch.
10. To remove all size and bag limits on white perch in Washington County, and to make the open season conform with the general law ice fishing and open water fishing seasons in all waters.
