## Chapter 89

### RESOLVE, Designating New Bridge at Guilford as "Guilford Memorial Bridge."

"Guilford Memorial Bridge" designated. Resolved: That the new bridge on State Highway Route No. 15 across the Piscataquis River in Guilford, County of Piscataquis, be officially named and referred to as "Guilford Memorial Bridge", and dedicated to the Veterans of All Wars.

## Chapter 90

### RESOLVE, Providing for Construction of a Substitute Road in Howland.

Construction of a substitute road in Howland authorized. Resolved: That the State Highway Commission, the Penobscot county commissioners, and the inhabitants of the town of Howland are hereby authorized to act as a joint board under the provisions of law set forth in section 108 to 116 of chapter 23 of the Revised Statutes for the purpose of appropriating money for the constructing and laying out of about 2.2 miles of road in the town of Howland to take the place of an existing road near the west bank of the Penobscot river, north of Howland Village and leading to Mattamiscontis Township and the town of Chester.

## Chapter 91

### RESOLVE, in Favor of Dudley Carter of Newport.

Dudley Carter; reimbursed. Resolved: That there be and hereby is appropriated from the State Highway Fund the sum of \$679 to be paid to Dudley E. Carter of Newport to reimburse him for losses not compensated by the State Highway Commission in connection with a P. E. Soucie Company Contract on Route 9 in Dixmont in the year 1952.

## Chapter 92

### RESOLVE, Granting Master Plumber's License to Ernest L. Douglass of Bangor.

Ernest L. Douglass granted master plumber's license. Resolved: That the Plumbers' Examining Board be, and hereby is, authorized and directed to license Ernest L. Douglass of Bangor as a master plumber without examination and on payment of a fee of \$20.
