## Chapter 117

**RESOLVE, to Reimburse the City of South Portland for Support of Margaret Dawson.**

**City of South Portland; reimbursed. Resolved:** That the sum of \$1,027.16 be, and hereby is, appropriated to be paid to the city of South Portland to reimburse said city for support of Margaret Dawson; said sum to be paid from the general fund of the state.

Effective August 20, 1955

## Chapter 118

**RESOLVE, in Favor of Gerard Pomerleau of Portland.**

**Gerard Pomerleau; compensated. Resolved:** That there be, and hereby is, appropriated the sum of \$110 from the general fund to be paid to Gerard Pomerleau, of Portland, as a full and final settlement for his claim against the state for damage to his car and contents by four state wards.

Effective August 20, 1955

## Chapter 119

**RESOLVE, in Favor of Calais Armory Project.**

**Emergency preamble.** Whereas, the National Guard unit at this location has never had an armory facility satisfactory for training and property storage purposes; and

Whereas, the State Military Defense Commission placed the Calais project in No. 1 priority following the passage by the Federal Congress of the Facilities and Construction Act; and

Whereas, the National Guard Bureau has allocated the funds in amount of \$112,500, and has programed this project for construction in 1955; and

Whereas, it is vitally necessary that this Resolve be immediately passed in order to use the allocated funds; and

Whereas, in the judgment of the legislature, these facts create an emergency within the meaning of the constitution of Maine, and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

**Calais armory project; appropriation for. Resolved:** That the sum of \$30,000 be, and hereby is, appropriated from the unappropriated surplus of the general fund for support of the construction of an armory in the city of Calais, provided that a like sum be made available for such construction by the municipal officers of the city of Calais.
