#### Chapter 156

RESOLVE, in Favor of Cyril Swallow of South Paris.

Cyril Swallow; reimbursed. Resolved: That there be, and hereby is, appropriated from the general fund of the state the sum of \$10 to be paid to Cyril Swallow of South Paris, as a full and final settlement of his claim against the State for the loss of a jacket taken by an escapee from the Men's Reformatory at South Windham.

Effective August 20, 1955

#### Chapter 157

RESOLVE, in Favor of Robert S. Robinson of Westbrook.

Robert S. Robinson; reimbursed. Resolved: That there be, and hereby is, appropriated from the general fund of the State the sum of \$219.38 to be paid to Robert S. Robinson of Westbrook, as a full and final settlement of his claim against the State for damage done to personal property and personal property taken by 2 escapees from the Reformatory at South Windham on June 2, 1953.

Effective August 20, 1955

#### Chapter 158

RESOLVE, in Favor of Philip Krisilos of Portland.

Philip Krisilos; reimbursed. Resolved: That there be, and hereby is, appropriated from the general fund of the State the sum of \$71.89 to be paid to Philip Krisilos of Portland, as a full and final settlement of his claim against the State for damage done to his restaurant known as the Anchor Lunch at 15 Portland Pier in the City of Portland, by escapees from the State School for Boys in South Portland, on April 29, 1954.

Effective August 20, 1955

### Chapter 159

RESOLVE, in Favor of Allie Cota of Gray.

Allie Cota; reimbursed. Resolved: That there be, and hereby is, appropriated from the general fund of the State the sum of \$600 to be paid to Allie Cota of Gray, as a full and final settlement of his claim against the State for damage done to his house trailer by inmates of Pownal State School who burned the trailer causing total loss, on July 3, 1953.
