Chapter 162

RESOLVE, in Favor of the Richmond, Maine, Camp Grounds of the Church of the Nazarene.

Maine Nazarene Campgrounds Incorporated; reimbursed. Resolved: That there be, and hereby is, appropriated from the general fund of the State the sum of \$1,394.62 to be paid to the Maine Nazarene Campgrounds Incorporated of Richmond, as a full and final settlement for claim against the State for damage done to the property of The Richmond, Maine, Camp Grounds of the Church of the Nazarene in April, 1954, by escapees from the State School for Boys.

Effective August 20, 1955

Chapter 163

RESOLVE, to Reimburse Town of Washington for Support of Certain State Paupers.

Town of Washington; reimbursed. Resolved: That there be, and hereby is, appropriated from the general fund of the state the sum of \$419.62 to be paid to the town of Washington to reimburse them for aid given to Dorothy Bender, William F. Nickerson and Ronald Newton, state paupers.

Effective August 20, 1955

Chapter 164

RESOLVE, in Favor of the Town of New Gloucester.

Town of New Gloucester; appropriation for. Resolved: That there be, and hereby is, appropriated in favor of the town of New Gloucester, the sum of \$3,000 for the fiscal year ending June 30, 1956, and the sum of \$3,000 for the fiscal year ending June 30, 1957, for tuition for children of Opportunity Farm who are being educated in the public schools of New Gloucester; such amount to be paid from the general fund of the state on requisition of the Commissioner of Education.

Chapter 165

RESOLVE, in Favor of John J. McDonough of Westbrook.

John J. McDonough; reimbursed. Resolved: That there be, and hereby is, appropriated from the general fund of the state the sum of \$264.61 to be paid to John J. McDonough of Westbrook, as a full and final settlement of his claim against the State, for damage done to his 1948 4-door Chevrolet Sedan, by 2 State School Boys while they were on escape.
