## Chapter 90

### AN ACT Repealing Certain Game Preserves and Sanctuaries.

*Be it enacted by the People of the State of Maine, as follows:*

Sec. 1. R. S., c. 37, § 149, amended. That part of section 149 of chapter 37 of the Revised Statutes, as revised, which relates to Augusta Game Preserve, is hereby repealed.

Sec. 2. R. S., c. 37, § 149, amended. That part of section 149 of chapter 37 of the Revised Statutes, as revised, which relates to Maranacook Game Preserve, is hereby repealed.

Sec. 3. R. S., c. 37, § 149, amended. That part of section 149 of chapter 37 of the Revised Statutes, as revised, which relates to Natanis Game Preserve, is hereby repealed.

Sec. 4. R. S., c. 37, § 149, amended. That part of section 149 of chapter 37 of the Revised Statutes, as revised, which relates to Stockholm Game Preserve, is hereby repealed.

## Chapter 91

### AN ACT Relating to Payments to County Law Libraries in Aroostook County.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 89, § 135, amended. That part of section 135 of chapter 89 of the Revised Statutes which relates to Aroostook county is hereby amended to read as follows:

'Aroostook, ~~\$2,500~~ \$3,300 of which ~~\$1,700~~ \$2,200 shall be for the use and benefit of the county law library in the court house at Houlton in said county and ~~\$800~~ \$1,100 shall be for the use and benefit of the county law library in the court house at Caribou in said county.'
