CHAP. 201

State to be sailed or transported outside the State immediately upon delivery by the seller.'

Emergency clause. In view of the emergency cited in the preamble, this act shall take effect when approved.

Effective April 26, 1957

#### Chapter 200

AN ACT Relating to the Importation of Liquors Used in Manufacture.

Be it enacted by the People of the State of Maine, as follows:

- R. S., c. 61, § 63, sub-§ II, amended. Subsection II of section 63 of chapter 61 of the Revised Statutes is hereby amended to read as follows:
  - 'II. To duly licensed distillers and manufacturers of spirituous or vinous liquors in this State for use as an ingredient in distilling or manufacturing spirituous or vinous liquors and such other spirituous or vinous products as may be authorized by Federal Regulations 26CFR;'

### Chapter 201

AN ACT Relating to Compensation under Workmen's Compensation Act for Loss of Distal Phalanx of Thumb, Finger or Toe.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 31, § 13, amended. The 12th paragraph from the end of section 13 of chapter 31 of the Revised Statutes is hereby amended to read as follows:

'The loss of the \*\*st\* distal (second) phalanx of the thumb or the distal (third) phalanx of any finger shall be considered to be equal to the loss of ½ of said thumb or finger, and the compensation therefor shall be ½ the amount above specified. The loss of more than one phalanx shall be considered as the loss of the entire thumb or finger. Provided, however, that in In no case shall the amount received for the loss of a thumb and more than one finger of the same hand exceed the amount specified in this schedule for the loss of a hand.'

Sec. 2. R. S., c. 31, § 13, amended. The 9th paragraph from the end of section 13 of chapter 31 of the Revised Statutes is hereby amended to read as follows:

'The loss of the  $\frac{1}{1}$  distal (second) phalanx of  $\frac{1}{2}$  the great toe or of the distal (third) phalanx of any other toe shall be considered to be equal to the loss of  $\frac{1}{2}$  of said great toe or any other toe, and the compensation therefor shall be  $\frac{1}{2}$  the

amount above specified. The loss of more than one phalanx shall be considered as the loss of the entire toe.'

#### Chapter 202

AN ACT Relating to Persons to Whom Liquor Licenses May Not Be Issued.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 61, § 29, amended. Section 29 of chapter 61 of the Revised Statutes, as amended by section 2 of chapter 71 of the public laws of 1955, is hereby further amended by inserting before the last sentence thereof, a new sentence, as follows:

'No person whose license for sale of liquor expires pending an appeal from conviction of a violation of law forbidding sale of intoxicating liquor on Sunday, by himself or his clerk, servant or agent, on his licensed premises, shall, after subsequent final conviction of himself, clerk, servant or agent be eligible for a liquor license for a period not exceeding 5 years from the date of such final conviction.'

### Chapter 203

AN ACT to Revise the Laws Relating to Registration of Accountants.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 80, § 1, amended. The last sentence of the 1st paragraph of section 1 of chapter 80 of the Revised Statutes is hereby amended to read as follows:

'Two All members of said Board shall be skilled in the art of accounting and shall have been actively engaged in the profession of a public accountant; they shall be holders of certificates issued under the provisions of this chapter; the other member shall be a practicing attorney in good standing in the courts of this state.'

Sec. 2. R. S., c. 80, § 4, amended. The last sentence of section 4 of chapter 80 of the Revised Statutes is hereby amended to read as follows:

'To those who have shown the required proficiency in the theory of accounts, practical accounting, auditing, business systems and commercial law and such other subjects as it deems necessary and whom it believes to be of such character and fitness as to qualify them to act as public accountants, it shall issue a certificate over the signatures of the members of the Board and under its seal that the applicant is entitled to practice as a certified public accountant in accordance with the provisions of this chapter.'
