Sec. 61. Penalty. Any person who violates any provisions of sections 54 to 58, inclusive, or conducts a business of dealer or repairman without having a certificate then in full force shall be fined not more than \$100 for the first offense, and not more than \$200 for each subsequent offense.

Sec. 62. Exclusion. Sales of any commodities by the manufacturers thereof under written purchase orders or contracts which clearly stipulate the weight or unit measure or other basis upon which the selling price is based, or which fix the selling price pursuant to established trade practices or customs in the industry, may be made in accordance with the provisions of such purchase orders or contracts notwithstanding any of the provisions of sections 25 to 30, inclusive.'

Sec. 2. R. S., c. 32, § 106, amended. The 1st sentence of section 106 of chapter 32 of the Revised Statutes is hereby amended to read as follows:

'Glass bottles and jars used for the sale of milk or cream shall be of one of the following capacities only: one gallon, a multiple of the gallon, 2 quarts, one quart, one pint,  $\frac{3}{8}$  of one pint,  $\frac{1}{2}$  of one pint or one gill and shall be sealed as full measure under the provisions of ~~section 208 of chapter 100~~ chapter 32-A or by the manufacturer, as provided in section 107.'

Sec. 3. R. S., c. 32, §§ 311-319, repealed. Sections 311 to 319, inclusive, of chapter 32 of the Revised Statutes, as amended, are hereby repealed.

Sec. 4. R. S., c. 100, §§ 165-173, repealed. Sections 165 to 173, inclusive, of chapter 100 of the Revised Statutes are hereby repealed.

Sec. 5. R. S., c. 100, §§ 202-228, repealed. Sections 202 to 228, inclusive, of chapter 100 of the Revised Statutes are hereby repealed.

## Chapter 261

### AN ACT Relating to Packing of Food.

*Be it enacted by the People of the State of Maine, as follows:*

Sec. 1. R. S., c. 32, § 228-A, additional. Chapter 32 of the Revised Statutes is hereby amended by adding thereto a new section to be numbered 228-A, to read as follows:

#### 'Packing of Food.

Sec. 228-A. Packing of food; permit; inspection. The Commissioner shall, upon application for permit and receipt of such fee as he deems necessary from any food packer or processor, inspect all operations of said packer or processor for compliance with the provisions of the Maine Food Law and shall cause the same law to be diligently enforced. Each such permit shall cover one group of buildings constituting a packing plant in one location.

Only the holder of such a permit may mark or label any food so inspected as packed or processed or inspected and passed under provisions of the Maine Food Law.

Said Commissioner may cancel any permit whenever there is a lack of compliance with the Maine Food Law. He shall establish such rules and regulations as he deems necessary. He shall make such charges as will be reasonable and as nearly as may be to cover the cost of the service rendered. All such fees and all such money thus collected for services rendered by the Commissioner shall be paid by him to the Treasurer of State. Said fees and money are appropriated for the purposes of this section.

The Commissioner may employ such agents and assistants, subject to the provisions of the Personnel Law, and make such purchases as may be necessary in the performance of his duties.'

## Chapter 262

AN ACT Relating to False Report of Deposit of Bombs or Other Infernal Devices.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 130, § 22-A, additional. Chapter 130 of the Revised Statutes is hereby amended by adding thereto a new section to be numbered 22-A, to read as follows:

'Sec. 22-A. False report as to bomb. Whoever calls out or causes to be called out any fire department, police department or other municipal department, or any portion or persons thereof, by intentionally giving a false report as to the deposit of any bomb or infernal machine in any public place, or in or upon any public conveyance, including but not limited to aircraft, or causes the evacuation of any public place or public conveyance by such false report, knowing such report to be false, shall be punished by a fine of not more than \$1,000 or by imprisonment for not more than 5 years, or by both.'
