Chapter 282

AN ACT Increasing Compensation of Members of Boards of Registration in Cities over 39,000 Inhabitants and Time of Sessions.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 3, § 13, amended. The 2nd paragraph of section 13 of chapter 3 of the Revised Statutes, as amended by section 1 of chapter 396 of the public laws of 1955, is hereby further amended to read as follows:

'In cities of 39,000 inhabitants and ~~less than 50,000 inhabitants~~ over, the chairman of the board shall receive ~~\$3,050~~ \$3,250 per year and the other 2 members of the board shall receive ~~\$2,700~~ \$2,900 per year and such additional amounts as may be authorized by the municipal officers or board of finance.'

Sec. 2. R. S., c. 3, § 16, amended. The 1st and 2nd sentences of section 16 of chapter 3 of the Revised Statutes are hereby amended to read as follows:

'In cities of 30,000 inhabitants or more, boards of registration shall be in session every day of the year, Saturdays, Sundays and court holidays excepted, for the purpose of registration and enrollment of voters and to revise and correct the voting list. Open sessions shall be held for the purpose of registration and enrollment of voters from 9 to 12 o'clock in the morning, and from 2 to 5 o'clock in the afternoon ~~Saturday afternoon excepted.~~'

Sec. 3. Limitation. The salary increases provided for in section 1 of this act shall not apply to any member of the 98th Legislature.

'The number of medical examiners so to be appointed shall be as follows: For the counties of Franklin, Knox, Lincoln, Piscataquis, Sagadahoc, Somerset and Waldo, 2 each; for the counties of Hancock, Oxford and Washington, 3 each; for the counties of Kennebec and York, 4 each; for the counties of Androscoggin and Aroostook, 5 each; ~~and for the counties of Cumberland and Penobscot, 6 each~~ for the county of Cumberland, 6; and for the county of Penobscot, 7; and they shall be appointed with reference to territorial distribution.'

Chapter 285

AN ACT Relating to Proration of Registration Fees of Motor Buses in Interstate Commerce.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 22, § 16, sub-§ I, ¶ C, sub-¶ 2, amended. Subparagraph 2 of paragraph C of subsection I of section 16 of chapter 22 of the Revised Statutes is hereby amended by inserting after the 1st sentence a new sentence to read as follows:

'Except that notwithstanding any other provisions in this section, an owner or operator of interstate motor buses used for the transportation of passengers for hire, operating a fleet of 2 or more motor buses under the authority of the Interstate Commerce Commission and the Public Utilities Commission, shall register and pay registration fees, as scheduled in this section, for that number of motor buses of the owner or operator as the proportion which the mileage of all such motor buses of the owner or operator, operated in this State bears to the total mileage of all such motor buses of the owner or operator operated both within and without the State in accordance with the owner or operator or his or its predecessor's operation of the preceding year, and the Secretary of State is authorized to promulgate such rules and regulations as may be necessary to effectuate such apportionment.'
