CHAP. 301

PUBLIC LAWS, 1957

'A municipality or community school district obligated to make payments to the Maine School Building Authority on December 1st of any given year may apply in writing through its municipal officers or its board of trustees to the Commissioner of Education setting forth the amount due, the date due, and the name of the trustee of the Maine School Building Authority and their statement that they desire that the amount thus specified be paid out of moneys apportioned to municipalities or community school districts be paid directly to the trustee therein designated prior to the due date. If the Commissioner and the Treasurer of the State approve the request, the amount therein specified shall be paid directly to the trustee named prior to the due date, notwithstanding any other limitations contained in this section. Requests for such direct payment shall be made during the year in which such payment is due on or after September 15th but no later than November 1st.'

Chapter 301

AN ACT Authorizing a Motor Vehicle for Driver Education.

Emergency preamble. Whereas, the Department of Education has been offered, free of charge, valuable equipment to be used in connection with the driver education program; and

Whereas, such equipment will not be furnished unless the Department has a suitable vehicle for its transport; and

Whereas, ample funds are available during the fiscal year 1956-1957 but will lapse unless this vehicle is purchased before July 1, 1957; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 41, § 218-C, additional. Chapter 41 of the Revised Statutes is hereby amended by adding thereto a new section to be numbered 218-C, to read as follows:

'Sec. 218-C. Motor vehicle authorized. Notwithstanding the provisions of section 30 of chapter 16, the Department of Education shall be permitted to purchase a motor vehicle to be used principally in carrying out the purposes of sections 218-A and 218-B.'

Emergency clause. In view of the emergency cited in the preamble, this act shall take effect when approved.
