## Chapter 417

### AN ACT to Increase Salaries of Justices of Supreme Judicial Court and Superior Court.

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. R. S., c. 103, § 4, amended.** The 1st sentence of section 4 of chapter 103 of the Revised Statutes, as amended by section 1 of chapter 472 of the public laws of 1955, is hereby further amended to read as follows:

'The Justices of the Supreme Judicial Court shall each receive an annual salary of ~~\$12,000~~ \$13,000, and the Chief Justice of the Supreme Judicial Court shall receive an annual salary of ~~\$13,000~~ \$14,000.'

**Sec. 2. R. S., c. 106, § 2, amended.** The 1st sentence of section 2 of chapter 106 of the Revised Statutes, as amended by section 2 of chapter 472 of the public laws of 1955, is hereby further amended to read as follows:

'Each of the Justices of the Superior Court shall receive an annual salary of ~~\$11,500~~ \$12,500.'

**Sec. 3. P. L., 1945, c. 331, § 3, repealed.** Section 3 of chapter 331 of the public laws of 1945 is hereby repealed.

**Sec. 4. P. L., 1951, c. 403, § 3, repealed.** Section 3 of chapter 403 of the public laws of 1951 is hereby repealed.

**Sec. 5. Appropriation.** There is hereby appropriated from the general fund the sum of \$14,208 for the fiscal year ending June 30, 1958 and \$15,500 for the fiscal year ending June 30, 1959, to carry out the purposes of this act.

## Chapter 418

### AN ACT Increasing Salaries of Various Department Heads and Commissions.

**Emergency preamble.** Whereas, the recruitment and retention of high caliber employees has been seriously affected by limitations imposed by existing salary levels; and

Whereas, there is currently before this Legislature appropriate measures to adjust the official salary schedules of the State in varying degrees for nearly all classes of employment prior to the beginning of the next fiscal year; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. R. S., c. 10, § 26, sub-§ VII, amended.** The last sentence of subsection VII of section 26 of chapter 10 of the Revised Statutes, as amended by section one of chapter 473 of the public laws of 1955, is hereby further amended to read as follows:

'He (Director of Legislative Research) shall receive a salary of ~~\$\$,000~~ \$9,000 per year and any necessary traveling expenses;'

(There is hereby appropriated from the general fund the sum of \$1,000 for the fiscal year ending June 30, 1958 and \$1,000 for the fiscal year ending June 30, 1959 to carry out the purposes of this section.)

**Sec. 2. R. S., c. 14, § 11, amended.** The 9th paragraph of section 11 of chapter 14 of the Revised Statutes, as amended by section 2 of chapter 473 of the public laws of 1955, is hereby amended to read as follows:

'The Adjutant General shall receive an annual salary of ~~\$\$,000~~ \$9,000.; ~~he~~ He shall receive no other fee, emolument or perquisite.'

(There is hereby appropriated from the general fund the sum of \$1,000 for the fiscal year ending June 30, 1958 and \$1,000 for the fiscal year ending June 30, 1959 to carry out the purposes of this section.)

**Sec. 3. R. S., c. 18, § 1, amended.** The 2nd paragraph of section one of chapter 18 of the Revised Statutes, as amended by section 3 of chapter 473 of the public laws of 1955, is hereby further amended to read as follows:

'The Treasurer of State shall receive an annual salary of ~~\$\$,000~~ \$6,750.; ~~he~~ He shall receive no other fee, emolument or perquisite.'

(There is hereby appropriated from the general fund the sum of \$750 for the fiscal year ending June 30, 1958 and \$750 for the fiscal year ending June 30, 1959 to carry out the purposes of this section.)

**Sec. 4. R. S., c. 19, § 1, amended.** The last sentence of section one of chapter 19 of the Revised Statutes, as amended by section 4 of chapter 473 of the public laws of 1955, is hereby further amended to read as follows:

'He (State Auditor) shall receive an annual salary of ~~\$\$,000~~ \$9,000.'

(There is hereby appropriated from the general fund the sum of \$1,000 for the fiscal year ending June 30, 1958 and \$1,000 for the fiscal year ending June 30, 1959 to carry out the purposes of this section.)

**Sec. 5. R. S., c. 20, § 1, amended.** The 6th sentence of section one of chapter 20 of the Revised Statutes, as amended by section 5 of chapter 473 of the public laws of 1955, is hereby further amended to read as follows:

'The Attorney General shall have an office in the State Capitol and shall receive an annual salary of ~~\$\$,000~~ \$9,000 in full for all services and in lieu of all fees.'

(There is hereby appropriated from the general fund the sum of \$1,000 for the fiscal year ending June 30, 1958 and \$1,000 for the fiscal year ending June 30, 1959 to carry out the purposes of this section.)

Sec. 6. R. S., c. 21, § 1, amended. The 2nd paragraph of section one of chapter 21 of the Revised Statutes, as amended by section 6 of chapter 473 of the public laws of 1955, is hereby further amended to read as follows:

'The Secretary of State shall receive an annual salary of ~~\$8,000~~ \$9,000. He and his deputy shall also receive such actual traveling expenses incident to the administration of his Department as shall be necessary.'

(There is hereby appropriated from the general fund the sum of \$1,000 for the fiscal year ending June 30, 1958 and \$1,000 for the fiscal year ending June 30, 1959 to carry out the purposes of this section.)

Sec. 7. R. S., c. 23, § 3, amended. The 5th sentence of section 3 of chapter 23 of the Revised Statutes is hereby amended to read as follows:

'The other members of the (Highway) Commission shall receive ~~\$4,000~~ \$4,500 per year and shall be appointed for a term of 3 years and any vacancies shall be filled for the unexpired term.'

Sec. 8. R. S., c. 29, § 4, sub-§ II, amended. Subsection II of section 4 of chapter 29 of the Revised Statutes, as amended by section 7 of chapter 473 of the public laws of 1955, is hereby further amended to read as follows:

**II. Salaries.** The Chairman of the Commission (Employment Security Commission) shall receive a fixed weekly salary, at the rate of ~~\$8,000~~ \$9,000 per year, and each of the other members shall receive a fixed weekly salary, at the rate of ~~\$7,500~~ \$8,450 per year, and shall be paid from the Employment Security Administration Fund.'

Sec. 9. R. S., c. 30, § 1, amended. The 5th sentence of section one of chapter 30 of the Revised Statutes, as amended by section 8 of chapter 473 of the public laws of 1955, is hereby further amended to read as follows:

'The Commissioner (Labor and Industry) shall receive an annual salary of ~~\$6,000~~ \$6,750, and in addition \$1,000 annually for his services as a member of the Industrial Accident Commission and his actual, necessary cash expenses while away from his office on official business of the Industrial Accident Commission.'

(There is hereby appropriated from the general fund the sum of \$750 for the fiscal year ending June 30, 1958 and \$750 for the fiscal year ending June 30, 1959 to carry out the purposes of this section.)

Sec. 10. R. S., c. 31, § 29, amended. The 1st sentence of the 3rd paragraph of section 29 of chapter 31 of the Revised Statutes, as amended by section 9 of chapter 473 of the public laws of 1955, is hereby further amended to read as follows:

'The Chairman (Industrial Accident Commission) shall receive a salary of ~~\$8,000~~ \$9,000 per year, and the other Commissioners a salary of ~~\$7,500~~ \$8,450 each per year.'

(There is hereby appropriated from the general fund the sum of \$2,900 for the fiscal year ending June 30, 1958 and \$2,900 for the fiscal year ending June 30, 1959 to carry out the purposes of this section.)

**Sec. 11. R. S., c. 32, § 1, amended.** The 3rd sentence of section one of chapter 32 of the Revised Statutes, as amended by section 10 of chapter 473 of the public laws of 1955, is hereby further amended to read as follows:

'He (Commissioner of Agriculture) shall receive an annual salary of ~~\$8,000~~ \$9,000.'

(There is hereby appropriated from the general fund the sum of \$1,000 for the fiscal year ending June 30, 1958 and \$1,000 for the fiscal year ending June 30, 1959 to carry out the purposes of this section.)

**Sec. 12. R. S., c. 36, § 1, amended.** The last sentence of section one of chapter 36 of the Revised Statutes, as amended by section 11 of chapter 473 of the public laws of 1955, is hereby further amended to read as follows:

'The Commissioner (Forestry) shall receive an annual salary of ~~\$10,000~~ \$11,250, of which amount ~~\$6,667~~ \$7,500 shall be paid from funds raised and created by the tax assessed under the provisions of section 96.'

**Sec. 13. R. S., c. 36, § 109, amended.** The last sentence of section 109 of chapter 36 of the Revised Statutes, as amended by section 12 of chapter 473 of the public laws of 1955, is hereby further amended to read as follows:

'The Commissioner (Forestry) shall also receive from said funds the sum of ~~\$6,667~~ \$7,500 per year in addition to the salary as now provided by law.'

(There is hereby appropriated from the general fund the sum of \$417 for the fiscal year ending June 30, 1958 and \$417 for the fiscal year ending June 30, 1959 to carry out the purposes of this section and section 12.)

**Sec. 14. R. S., c. 37, § 1, amended.** The 2nd paragraph of section one of chapter 37, as revised, is hereby amended to read as follows:

'The Commissioner (Inland Fisheries and Game) shall receive an annual salary of ~~\$8,000~~ \$9,000 and he shall also receive all necessary traveling expenses.'

**Sec. 15. R. S., c. 41, § 4, amended.** The 1st sentence of section 4 of chapter 41 of the Revised Statutes, as amended by section 13-A of chapter 473 of the public laws of 1955, is hereby further amended to read as follows:

'The Board shall appoint a Commissioner of Education, hereinafter in this chapter called the "Commissioner" whenever a vacancy occurs and fix his salary, not to exceed ~~\$10,000~~ \$11,250 per year.'

(There is hereby appropriated from the general fund the sum of \$1,250 for the fiscal year ending June 30, 1958 and \$1,250 for the fiscal year ending June 30, 1959 to carry out the purposes of this section.)

**Sec. 16. R. S., c. 44, § 1, amended.** The 1st sentence of the 2nd paragraph of section one of chapter 44 of the Revised Statutes is hereby amended to read as follows:

'The Chairman (Public Utilities Commission) shall receive a salary of ~~\$9,000~~ \$10,125 per year, and the other Commissioners a salary of ~~\$8,500~~ \$9,575 each per year.'

(There is hereby appropriated from the general fund the sum of \$3,275 for the fiscal year ending June 30, 1958 and \$3,275 for the fiscal year ending June 30, 1959 to carry out the purposes of this section.)

Sec. 17. R. S., c. 59, § 1, amended. The last sentence of the 1st paragraph of section one of chapter 59 of the Revised Statutes, as amended by section 14 of chapter 473 of the public laws of 1955, is hereby further amended to read as follows:

'He (Bank Commissioner) shall receive an annual salary of ~~\$8,000~~ \$9,000 and his actual traveling expenses incurred in the performance of his duties.'

Sec. 18. R. S., c. 60, § 2, amended. The 5th sentence of section 2 of chapter 60 of the Revised Statutes, as amended by section 15 of chapter 473 of the public laws of 1955, is hereby further amended to read as follows:

'He (Insurance Commissioner) shall receive an annual salary of ~~\$8,000~~ \$9,000.'

(There is hereby appropriated from the general fund the sum of \$1,000 for the fiscal year ending June 30, 1958 and \$1,000 for the fiscal year ending June 30, 1959 to carry out the purposes of this section.)

Sec. 19. R. S., c. 61, § 5, amended. Section 5 of chapter 61 of the Revised Statutes is hereby amended to read as follows:

'Sec. 5. Salaries and expenses. The salary of the Chairman of the (Liquor) Commission shall be ~~\$7,000~~ \$7,875 per year and the salary of each of the other members shall be ~~\$5,000~~ \$5,625 per year, and in addition each member shall be allowed his reasonable expense incurred in the performance of his duties; ~~provided, however, that such~~ Such expense shall not include travel between his place of residence and the Commission office, or board and lodging in the city or town where such office is located.'

Emergency clause. In view of the emergency cited in the preamble, this act shall take effect July 1, 1957.

## Chapter 419

### AN ACT Relating to Area Directional Signs.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 23, § 149-A, additional. Chapter 23 of the Revised Statutes is hereby amended by adding thereto a new section, to be numbered 149-A, to read as follows:

'Sec. 149-A. Area directional signs. In order to guide the users of the state turnpike system to the exit leading therefrom to the 8 major recreational areas of the State, there shall be erected and maintained at strategic points on the rights-of-way beside the lanes of traffic approaching the said exits, separate descriptive and directional signs of such design that each sign will be conspicu-
