Chapter 67

AN ACT Designating a Certain Road as "Moosehead Trail."

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. "Moosehead Trail," designated. The following described highway is hereby designated as the "Moosehead Trail": Beginning in Belfast at the junction of Route U. S. 1 and Route 3; thence on Route 7 to Newport and Dexter; thence on Route 23 to Sangerville and to the junction of Route 15 in Guilford; thence on Route 15 to Greenville and Jackman, ending at the junction of Route 15 and U. S. 201.

The State Highway Commission shall erect and maintain suitable signs designating the "Moosehead Trail."

Sec. 2. P. & S. L., 1951, c. 165, § 1, repealed. Section 1 of chapter 165 of the private and special laws of 1951, as amended by chapter 108 of the private and special laws of 1953, is hereby repealed.

Chapter 68

AN ACT Repealing Certain Provisions of Charter of the Town of Bar Harbor.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P. & S. L., 1949, c. 111, § 1, repealed and replaced. Section 1 of chapter 111 of the private and special laws of 1949, as repealed and replaced by section 1 of chapter 52 of the private and special laws of 1951, is hereby repealed and the following enacted in place thereof:

'**Sec. 1. Annual town meeting.** The annual town meeting shall be held in the town of Bar Harbor, in the county of Hancock, on the 3rd Monday of March in each year, and the voters shall then choose by ballot, as now provided by law, a moderator to preside at said meeting, after which the polls shall be open for the balloting for town officers named in section 2.'

Sec. 2. P. & S. L., 1949, c. 111, §§ 1-A and 1-B, repealed. Sections 1-A and 1-B of chapter 111 of the private and special laws of 1949, as enacted by section 1 of chapter 52 of the private and special laws of 1951, are hereby repealed.

Sec. 3. Ratification. All acts of the municipal officers of the town of Bar Harbor on or since August 20, 1951, are hereby ratified.
