Chapter 202

AN ACT to Ratify and Confirm the Incorporation of Free Library Association of Kennebunk, of Kennebunk in the County of York.

Whereas, Free Library Association of Kennebunk, of Kennebunk in the County of York and State of Maine, has had long and continuous existence; and

Whereas, in the records of the Association there is a copy of the publication of the required notice of the first meeting of the incorporators, including the application of the incorporators dated April 5, 1882, the warrant of a Justice of the Peace dated April 5, 1882, the attestation of a true copy dated April 5, 1882, calling a meeting of the incorporators on April 24, 1882; and

Whereas, the records of the Association indicate that it has been continuously in existence since that date, the library room in fact being opened on April 19, 1882; and

Whereas, at the time of its incorporation on the said 24th day of April, 1882, there was no statutory provision for recording its incorporation in any office of public record; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

Incorporation of Free Library Association of Kennebunk ratified. The incorporation of Free Library Association of Kennebunk, of Kennebunk in the County of York and State of Maine, is hereby declared to be in existence and to have been in existence since April 24, 1882; and all the acts of the members, officers and trustees of said corporation, as such, prior to the effective date of this act, are hereby ratified and confirmed; and the register of deeds in and for the County of York is hereby authorized and instructed to enter upon his records this validation of the incorporation of Free Library Association of Kennebunk in accordance with this act.

Chapter 203

AN ACT to Ratify and Make Valid the Incorporation of the Hebrew Synagogue Society of Portland, to Change its Name to Congregation Shaarey Tphiloh and for Other Purposes.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Incorporation of the Hebrew Synagogue Society of Portland. The incorporation of the Hebrew Synagogue Society, located at Portland, in the County of Cumberland and State of Maine, on May 28, 1900, as a religious corporation, in accordance with the provisions of the Revised Statutes of 1883, chapter 55, as amended by the public laws of Maine of 1897, chapter 192 (Revised Statutes of Maine 1954, chapter 57, section 28), is hereby ratified, affirmed and made valid, and all acts and doings of its members and officers, acting as a body corporate, as shown by the records thereof, are hereby approved, ratified and declared to be valid and legal.

Sec. 2. Authority for change of name. Whereas said Hebrew Synagogue Society has also been known as Hebrew Synagogue Society Shara Tefilah and Congregation Shaarey Tphiloh, having acquired title to real and personal property in each of said names, and is presently known as Congregation Shaarey Tphiloh, the acts of the corporation under any or all of said names are hereby ratified, affirmed and made valid; all acts and doings of the members and officers of the corporation under any of said names, as shown by the records thereof, are hereby approved, ratified and declared to be valid and legal; and it is hereby declared that said corporation may hereafter be legally known as Congregation Shaarey Tphiloh.

Sec. 3. Vesting of title to property. Title to all real estate and personal property held in the names of Hebrew Synagogue Society, Hebrew Synagogue Society Shara Tefilah or Congregation Shaarey Tphiloh is now declared to be vested in Congregation Shaarey Tphiloh and the officers of said Congregation Shaarey Tphiloh are hereby authorized and empowered:

- I. To transfer any or all of the property acquired in any of said names with or without consideration and upon such terms as it may choose;
- II. To sell and convey at public or private sale any or all of its said property; and
- III. To acquire title to real and personal property.

Sec. 4. Copy to be recorded. A copy of this act shall be recorded in the records of the Secretary of State and of the Registry of Deeds of Cumberland County in the same manner as certificates of incorporation are recorded.

Chapter 204

AN ACT to Set Off Part of Town of Benedicta to Town of Sherman.

Be it enacted by the People of the State of Maine, as follows:

Part of Town of Benedicta set off. All of Lot No. 30, as designated on Rae and Colby Plan dated 1877, in the Town of Benedicta, Aroostook County, shall be and hereby is set off from the Town of Benedicta and annexed to the Town of Sherman in Aroostook County.

Chapter 205

AN ACT Relating to Sources of Supply and Purposes of Yarmouth Water District.

Emergency preamble. Whereas, the existing water facilities in the Town of Yarmouth are inadequate for the needs of the inhabitants of said Town and the agricultural, commercial and industrial pursuits within the Town; and
