### Chapter 70

RESOLVE, Designating East Deering Expressway as Charles J. Loring, Jr. Memorial Highway.

East Deering Expressway; designated. Resolved: That in commemoration of the highly meritorious and selfless service of the late Charles J. Loring, Jr., of Portland, Major in the United States Air Force, rendered in the defense of his country during World War II, for which he made the supreme sacrifice and was awarded posthumously the Congressional Medal of Honor that the East Deering Expressway, extending from the junction of Veranda Street to Tukey's Bridge, be named the "Charles J. Loring, Jr. Memorial Highway" and that appropriate markers designating the name of the expressway be erected at appropriate intervals along said expressway by the State Highway Commission.

### Chapter 71

RESOLVE, Closing Sebago Lake, Cumberland County to Taking Smelts.

Sebago lake; closed to taking of smelts. Resolved: That the Commissioner of Inland Fisheries and Game be, and hereby is, authorized and directed to issue a rule and regulation closing Sebago lake, Cumberland county, to the taking of smelts for a period of 2 years from the effective date of this resolve.

### Chapter 72

RESOLVE, Authorizing the State Forest Commissioner to Convey Certain Lands and Right of Way in Augusta to Cumberland Securities Corporation.

State Forest Commissioner authorized to convey certain lands and right of way. Resolved: That the State Forest Commissioner be, and hereby is, authorized and empowered to sell and convey to Cumberland Securities Corporation, a Maine corporation having its office and principal place of business at Augusta, county of Kennebec and said State, for the sum of \$4,000, the following described property, to wit: (1) a certain lot or parcel of land situated on the northerly side of the Old Winthrop Road, so called, in said Augusta, and being described as follows: beginning at a stone bound set in the ground at the southeasterly corner of land conveyed to Cumberland Securities Corporation by James E. Tibbetts by deed dated March 6, 1956, recorded in Kennebec County Registry of Deeds, Book 1035, Page 1; thence extending northerly along the easterly line of land conveyed to Cumberland Securities Corporation by said deed of March 6, 1956, a distance of 1020 feet, more or less, to an iron pin set in the ground; thence extending south 61° 30' east a distance of 245 feet, more or less, to an iron pin set in the ground; thence extending south 21° 11' west to the northwesterly corner of lot No. 15 shown on plan recorded in Kennebec County Registry of Deeds, Plan Book 15, Pages 72 and 73, and being the northwesterly corner of land conveyed to E. Elliott and Mary E. Caldwell by John E. Cunningham, et al., by deed dated August 10, 1954, recorded in Kennebec
