Chapter 88

RESOLVE, Relating to Moneys to Obtain Plasma.

Resolves, 1951, c. 137, amended. Resolved: That Chapter 137 of the Resolves of 1951 be, and hereby is, amended to read as follows:

'Plasma; appropriating moneys to obtain. Resolved: That there be, and hereby is, appropriated from the General Fund the sum of \$15,375 for the purpose of supplying materials in connection with the accumulation, storage and maintenance of 5,000 units of liquid plasma and 500 units of dried plasma to be available in the event of a disaster; this money to be expended upon authorization by the Department of Health and Welfare. ~~Any unexpended balances shall not lapse but shall remain a continuing carrying account~~

Chapter 89

RESOLVE, Authorizing the Commissioner of Finance and Administration to Convey Certain Land of the State in York County.

Commissioner of Finance and Administration; convey land. Resolved: That the Commissioner of Finance and Administration be, and hereby is, authorized to convey by sale to the highest bidder, but for not less than \$15,000, the interest of the State in the following described land:

A certain parcel of land, with the buildings thereon, lying on the southeasterly side of the Lower Post Road, in Wells, in the county of York, bounded as follows: Beginning on the easterly side of said Road and at the northerly corner of the schoolhouse lot, known as School Division No. 1 in said Wells; thence running northeasterly by said Lower Post Road a distance of two hundred (200) feet to a hub and corner; thence turning and running at nearly right angles to the first described line and in a southeasterly direction a distance of one hundred (100) feet to a post and corner by land of William A. Goodwin; thence running southwesterly by other land of said Goodwin and on a line parallel with the first above described line, a distance of two hundred (200) feet to said schoolhouse lot; thence turning and running northwesterly by said schoolhouse lot one hundred (100) feet to said Lower Post Road and the point begun at.

Also a right to dig a ditch and lay drainage pipes from a certain ancient well located on the above described premises, for drainage purposes in a southeasterly direction from said well to extend over the brow of the hill in the rear or southeast of said described premises and to install a septic tank at the southeasterly end of said drainage pipes.

Meaning the same premises conveyed to the Inhabitants of the State of Maine by William A. Goodwin by his deed of warranty dated August 14, 1935 and recorded in the York County Registry of Deeds, Book 862, Page 104.

The amount realized from the sale shall be credited to the general highway fund.
