CHAP. 64

Whereas, the Maine School District Commission recommends that the municipalities of Eastport, Perry, Pembroke and Dennysville be authorized to establish a school administrative district; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine, and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

School administrative district for Eastport, Perry, etc.; authorized. The municipalities of Eastport, Perry, Pembroke and Dennysville are exempted from the limitations provided in the Revised Statutes of 1954, chapter 41, section III-E, as amended, and the Maine School District Commission is authorized to proceed pursuant to sections III-F to III-U to take the necessary action to allow the municipalities of Eastport, Perry, Pembroke and Dennysville to form a school administrative district.

Nothing contained herein shall be construed to limit the number of times that the above-named municipalities may make application to the Maine School District Commission, nor shall the authority granted to the Maine School District Commission under this act be limited to any specified number of times for the commission to authorize the above-named municipalities to act on the formation of a school administrative district.

Emergency clause. In view of the emergency cited in the preamble, this act shall take effect when approved.

Chapter 64

AN ACT Authorizing the National Tuberculosis Association to Hold Meetings Outside the State.

Be it enacted by the People of the State of Maine, as follows:

Organization validated; meetings outside Maine authorized. The National Tuberculosis Association, a corporation duly organized and existing under the laws of the State of Maine, which organization is hereby ratified, confirmed and declared to be legal and valid, is authorized and empowered to provide in its by-laws for the holding of meetings of its members either within or without the State, or both, and any business transacted or elections held at any such meeting held without the State shall be as valid as if transacted or held at a meeting within the State.
