## Chapter 98

### AN ACT Enlarging Territorial Limits of West Paris Village Corporation.

*Be it enacted by the People of the State of Maine, as follows:*

P. & S. L., 1921, c. 7, § 1, amended. Section 1 of chapter 7 of the private and special laws of 1921, as amended by chapter 10 of the private and special laws of 1929, is further amended by adding at the end 2 new paragraphs, to read as follows:

'The territorial boundaries of the corporation shall also include the following described area: Beginning at a point on the easterly limit of the West Paris Village Corporation northwesterly 500 feet from the northwesterly limit of Route 219, so called; thence northeasterly, maintaining a distance of 500 feet from the northwesterly limit of said Route 219, to Route 26, so called; thence southeasterly by said Route 26 to a point 500 feet southeasterly from the southeasterly limit of said Route 219; thence southwesterly, maintaining a distance of 500 feet from the southeasterly limit of said Route 219, to the easterly limit of said West Paris Village Corporation; thence northwesterly by the easterly limit of said West Paris Village Corporation to the point of beginning.

All references to the easterly limit of the West Paris Village Corporation relate to its existence as of January 1, 1959.'

## Chapter 99

### AN ACT Increasing Salary of Mayor of the City of Lewiston.

*Be it enacted by the People of the State of Maine, as follows:*

P. & S. L., 1939, c. 8, Art. IV, § 2, amended. The last sentence of section 2 of article IV of chapter 8 of the private and special laws of 1939, as last amended by chapter 208 of the private and special laws of 1951, is further amended to read as follows:

'The salary of the mayor shall be ~~\$2,500~~ \$3,500 for the term, which shall be in full for the performance of his official duties.'

## Chapter 100

### AN ACT Relating to Sick Leave for Members of Fire Department of City of Lewiston.

*Be it enacted by the People of the State of Maine, as follows:*

P. & S. L., 1939, c. 8, Art. XII, § 3-A, additional. Article XII of chapter 8 of the private and special laws of 1939, as amended, is further amended by adding a new section 3-A, to read as follows:

'Sec. 3-A. Sick leave. Members of the fire department shall be allowed to accumulate  $1\frac{1}{2}$  days of sick leave per month worked, a total of 18 days per year, accumulating to 70 days. At the termination of the employment of the member, he shall have no claim, monetary or other compensation, for any unused portion of days allowed for sick leave.'

## Chapter 101

AN ACT Amending the Charter of the Bowdoinham Water District.

*Be it enacted by the People of the State of Maine, as follows:*

Sec. 1. P. & S. L., 1957, c. 121, § 7, amended. The first sentence of section 7 of chapter 121 of the private and special laws of 1957 is amended to read as follows:

'The first board of trustees shall be appointed within 10 days after the acceptance of this act by the voters of said district, 2 to serve until the first annual meeting of the ~~district~~ board of trustees, 2 until the 2nd and one until the 3rd such meeting.'

Sec. 2. P. & S. L., 1957, c. 121, § 13, additional. Chapter 121 of the private and special laws of 1957 is amended by adding a new section 13, to read as follows:

'Sec. 13. Application. The provisions of the Revised Statutes of 1954, chapter 53, and amendments thereto, do not apply to the Bowdoinham Water District.'

## Chapter 102

AN ACT Relating to Employment of City Personnel in City of Lewiston.

*Be it enacted by the People of the State of Maine, as follows:*

P. & S. L., 1939, c. 8, Art. XVI, § 11-A, additional. Article XVI of chapter 8 of the private and special laws of 1939 is amended by adding a new section 11-A, to read as follows:

'Sec. 11-A. Preference for employment to be given city inhabitants. In considering applications for employment, all municipal authorities empowered to employ personnel shall give preference, whenever practicable, to qualified persons who are inhabitants of the City of Lewiston for at least 3 months. The provisions of this section shall not be applicable to school teachers and other professional personnel.'
