#### Chapter 165

AN ACT Creating a Committee to Study Establishment of a Residential Treatment Center for Emotionally Disturbed Children.

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. Committee; purpose. The Commissioner of Institutional Service shall appoint a committee of 3 persons to study, plan and make recommendations concerning the establishment of a residential treatment and rehabilitation center for emotionally disturbed children. The commissioner shall designate the chairman. The committee shall meet at the call of the chairman, and the members shall be paid necessary expenses incurred in the performance of their duties. The committee shall report the results of its study to the rooth Legislature.
- Sec. 2. Appropriation. There is appropriated from the Unappropriated Surplus of the General Fund the sum of \$1,000 for the fiscal year ending June 30, 1960 to carry out the purposes of this act. Any unexpended balances shall not lapse, but shall remain a continuing carrying account until June 30, 1961.

#### Chapter 166

AN ACT Establishing a State Committee on Children and Youth.

Emergency preamble. Whereas, the President of the United States has called a White House Conference on Children and Youth to meet in March, 1960; and

Whereas, the President has appointed a National Committee to receive suggestions and recommendations for subjects to be discussed; and

Whereas, the President's National Committee has set September 1, 1959 as a deadline for receipt of such suggestions; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. State Committee on Children and Youth created. The Governor shall appoint a committee of not more than 75 citizens representing all areas of interest in children and youth and shall designate a chairman.
- Sec. 2. Duties. The State Committee on Children and Youth shall prepare for the state's participation in the 1960 White House Conference on Children and Youth. It shall consider the current status of children and youth in Maine and it may undertake surveys of the causes and effects of problems relating to children and youth. The committee may make recommendations to the President's National Committee on Children and Youth as to matters to be brought to the attention of the 1960 White House Conference on Children and Youth.
