## Chapter 71

### RESOLVE, Authorizing the Maine Defense Commission to Convey Certain Land in Fort Kent.

Maine Defense Commission authorized to convey certain land. Resolved: That the Maine Defense Commission be, and hereby is, authorized and directed to convey by quitclaim deed to the Town of Fort Kent, the interest of the State in a certain piece or parcel of land on the westerly side of main highway, known as Pleasant Street, bounded and described as follows, to wit:

Land and premises situated in Township 18, Range 7, now a part of the Town of Fort Kent, in the County of Aroostook and State of Maine, a strip or parcel of land out of Original Lot N. 30, which is bounded as follows, to wit: On the westerly side of main highway, known as Pleasant Street; on the northerly side by land of Mattie Pinette; on the easterly side by the Fish River; and on the southerly side by land of G. H. Page on which is situated his potato starch factory.

Being the same premises as conveyed to the grantor by the deed of the estate of Thomas S. Pinkham, Sr. dated June 29, 1954, said deed to be recorded in the Northern District Aroostook Registry of Deeds.

## Chapter 75

### RESOLVE, Opening Sand Pond, Oxford County to Ice Fishing.

**Sand Pond; open to ice fishing. Resolved:** That the Commissioner of Inland Fisheries and Game be, and hereby is, authorized and directed to issue a rule and regulation opening Sand Pond, Denmark, Oxford County, to ice fishing during the months of February and March.

## Chapter 76

### RESOLVE, Regulating Fishing in Richardson Lakes, Upper and Lower, and Their Tributaries, Oxford County.

**Richardson Lakes, Upper and Lower and Tributaries, regulating fishing. Resolved:** That the Commissioner of Inland Fisheries and Game be, and hereby is, authorized and directed to issue a rule and regulation establishing a 5 fish limit in the aggregate from the waters of Richardson Lakes, Upper and Lower, and their tributaries and Rapid River and Pond-in-the-River, all in Oxford County, and prohibiting the use or possession of live fish as bait in these waters.

Fly fishing only, in that part of Richardson Lake from the mouth of Metallak Brook to a straight line drawn between 3 red posts, one set on the east shore of Pine Island, one on the mainland in a southerly direction from Pine Island and one on the mainland in a northeasterly direction from Pine Island. The above described area shall be closed one hour after sunset to one hour before sunrise of the following morning, except to the taking of smelts.

Fly fishing only, in that part of Richardson Lake from the mouth of Mosquito Brook to a straight line drawn between a red post set on the south shore of Mosquito Brook Cove approximately 300 feet from the mouth of said brook and a red post set on the north shore of said cove. The above described area shall be closed one hour after sunset to one hour before sunrise of the following morning, except to the taking of smelts.

Upper Dam Pool shall be defined as being that area between the dam at the outlet of Mooselookmeguntic Lake and a line drawn between the 2 rocks and cribwork piers approximately 800 yards west of the aforesaid dam and only fly fishing shall be permitted. Daily bag limit of one fish per person from September 15th to September 30th.

Metallak Brook and its tributaries shall be closed to all fishing except to the taking of smelts.
