CHAP. 78

RESOLVES, 1959

Rapid River and Pond-in-the-River shall be fly fishing only. From September 16th to September 30th, both Rapid River and Pond-in-the-River shall be open to fishing with a daily bag limit of one fish from either or both of these bodies of water; and be it further

Resolved: That any regulations inconsistent with this regulation be, and hereby are, repealed.

Chapter 77

RESOLVE, Establishing Daily Limit of Trout on Ledge Pond, Town of Charlotte, Washington County.

Ledge Pond; regulating fishing. Resolved: That the Commissioner of Inland Fisheries and Game be, and hereby is, authorized and directed to issue a rule and regulation establishing a 5 trout daily limit on Ledge Pond in the Town of Charlotte, Washington County.

Chapter 78

RESOLVE, Refunding Motor Vehicles Fees to Certain Canadian Residents.

Canadian residents; reimbursed. Resolved: That there be, and hereby is, appropriated from the General Highway Fund the sum of \$3,109 to pay the persons hereinafter named, the total sums set opposite their respective names, being a full and final settlement of the claims against the State of Maine for motor vehicle excise taxes, registration fees and operators' licenses paid under a mistaken interpretation of the law.

Chapter 79

RESOLVE, Permitting Ice Fishing in Certain Ponds in Androscoggin and Kennebec Counties.

Ice fishing in certain ponds; regulated. **Resolved:** That the Commissioner of Inland Fisheries and Game be, and hereby is, authorized and directed to issue a rule and regulation opening to ice fishing under the general laws the following ponds:

Rack Pond, East Livermore, Androscoggin County;

Round Pond, East Livermore, Androscoggin County;

Turner Pond, East Livermore, Androscoggin County;

Burgess Pond, Fayette, Kennebec County;

Mud Pond, Fayette, Kennebec County;

School House Pond, East Livermore, Androscoggin County, and Fayette, Kennebec County; and be it further

Resolves, 1959, c. 42, amended. Resolved: That chapter 42 of the resolves of 1959 be, and hereby is, amended to read as follows:

'Fishing in Maranacook Lake; regulated. **Resolved:** That the Commissioner of Inland Fisheries and Game be, and hereby is, authorized and directed to issue a rule and regulation opening Maranacook Lake, in the Town of Winthrop and the Town of Readfield, Kennebec County, to ice fishing for all fish except bass during February and March. There shall be a daily bag limit of 5 trout which shall not exceed a weight of 7½ pounds.'
