## Chapter 99

### RESOLVE, In Favor of Edmund D. Schorr of Kittery.

Edmund D. Schorr; reimbursed. Resolved: That there be, and hereby is, appropriated from the Unappropriated Surplus of the General Fund the sum of \$500 to reimburse Edmund D. Schorr, Kittery, for personal injuries and damage to his automobile when he hit an iron bar on Memorial Bridge which spans the Piscataqua River.

## Chapter 100

### RESOLVE, in Favor of Ernest S. Stone of Garland.

Ernest S. Stone; reimbursed. Resolved: That there be, and hereby is, appropriated from the Unappropriated Surplus of the General Fund the sum of \$300 to be paid to Ernest S. Stone of Garland for the loss of one heifer.

## Chapter 101

### RESOLVE, Appropriating Moneys for LP Gas Prover for State Sealer of Weights and Measures.

LP gas prover; appropriation for. Resolved: That there be, and hereby is, appropriated from the Unappropriated Surplus of the General Fund the sum of \$7,500 to be paid to the Department of Agriculture for the purchase of a truck, together with LP gas prover, to be used by the State Sealer of Weights and Measures to carry out his statutory duties.

## Chapter 102

### RESOLVE, to Reimburse Old Town School Department for Tuition for Children Living on Indian Island.

Old Town school department; reimbursed. Resolved: That there be, and hereby is, appropriated from the Unappropriated Surplus of the General Fund the sum of \$3,785.01 to be paid to the school department of Old Town to pay said town for the tuition of children living on Indian Island for the school years 1956-57, 1957-58 and 1958-59.

Effective September 12, 1959
