Resolved: That there be, and hereby is, appropriated from the Unappropriated Surplus of the General Fund the sum of \$250 for this purpose.

Chapter 110

RESOLVE, Appropriating Moneys for Restoration of Certain Forts in Aroostook County.

Restoration of certain forts in Aroostook County; appropriation. **Resolved:** That there be, and hereby is, appropriated from the Unappropriated Surplus of the General Fund the sum of \$5,000 to Aroostook County for restoration of the following forts in Aroostook County:

Fort Fairfield at Fort Fairfield;

Fort Kent at Fort Kent;

Hancock Barracks at Houlton.

The expenditure of the appropriation shall be under the supervision of the county commissioners of Aroostook County. Any unexpended balances shall not lapse but shall remain a continuing carrying account until June 30, 1961.

RESOLVE Providing for Biographical Sketches of Maine Composers.

Biographical sketches of Maine composers; appropriation for. **Resolved:** That there be, and hereby is, appropriated from the Unappropriated Surplus of the General Fund for the fiscal year ending June 30, 1960, the sum of \$750, to the State Library for distribution to all libraries in Maine of a booklet containing the biographical sketches of Maine composers and their compositions, to be published by the Maine Federation of Music Clubs.

"The Story of Houlton"; purchase of. **Resolved:** That the State purchase 50 copies of "The Story of Houlton," compiled by Cora M. Putnam, at a price

Resolved: That there be, and is, appropriated from the Unappropriated Surplus of the General Fund the sum of \$500 for this purpose.

RESOLVE, Providing for Purchase of History of the Town of Unity.

"History of the Town of Unity, Maine"; purchase of. Resolved: That there be, and is, appropriated from the Unappropriated Surplus of the General Fund the sum of \$450 to be used for the purchase of 50 copies of "History of the Town of Unity, Maine," written and published by James B. Vickery in 1954, these copies to be exchanged or distributed at the discretion of the State Librarian.

Chapter 114

RESOLVE, Appropriating Moneys to Aid Construction of Dormitory at Higgins Classical Institute.

Dormitory at Higgins Classical Institute; appropriation. Resolved: That there be, and hereby is, appropriated from the Unappropriated Surplus of the General Fund the sum of \$25,000 in favor of Higgins Classical Institute to aid in construction of a boys' dormitory.

Chapter 115

RESOLVE, in Favor of Grand Falls Hospital, Grand Falls, New Brunswick.

Grand Falls Hospital; reimbursed. Resolved: That there be, and hereby is, appropriated from the Unappropriated Surplus of the General Fund the sum of \$1,000 to be paid to Grand Falls Hospital, Grand Falls, New Brunswick, for the fiscal year ending June 30, 1960 for hospitalization for Philip Theriault, Jr. of Van Buren.
