---

**Chapter 128**

**RESOLVE, Providing for Decrease in Retirement Benefit for Helen D. Perry of Rockland.**

Helen D. Perry; retirement benefit decreased. **Resolved:** That the retirement benefit now being paid to Helen D. Perry of Rockland, under the Revised Statutes, chapter 63-A, be decreased from \$1,404 per year to \$1,380 per year, to be retroactive to January 1, 1960.

**Chapter 129**

**RESOLVE, Appropriating Moneys for Spruce Budworm Control.**

**Emergency preamble.** Whereas, acts and resolves of the Legislature do not become effective until 90 days after adjournment; and

Whereas, a severe outbreak of spruce budworm has developed in the forests of northern Maine, threatening the destruction of one of Maine's outstanding natural resources; and

Whereas, the following legislation is vitally necessary to control this outbreak so as to save 175,000 acres of Maine forest; and

Whereas, in the judgment of the Legislature these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

**Spruce budworm control. Resolved:** That there be, and is, appropriated \$65,625 from the General Fund to be expended by the Forest Commissioner or his agents for spruce budworm control as the state's share with the rest of the funds for control supplied by landowners and the Federal Government; and

any unexpended balances shall not lapse but shall remain a continuing carrying account until June 30, 1961.

**Emergency clause.** In view of the emergency cited in the preamble, this resolve shall take effect when approved.

## Chapter 130

**RESOLVE, in Favor of the Town of Danforth for School Construction Aid.**

**Town of Danforth; school construction aid for. Resolved:** That there be, and hereby is, appropriated from the General Fund the sum of \$50,000 to be paid to the Town of Danforth as a hardship grant for school construction aid. Said sum shall be expended on school construction in the Town of Danforth. In the event that the Town of Danforth becomes a part of a School Administrative District, said grant shall be used by the School Administrative District to construct buildings in the Town of Danforth for the schooling of district pupils.

## Chapter 131

**RESOLVE, Providing Matching Funds for Federal National Defense Education Act Allotments.**

**Matching funds for Federal National Defense Education Act; appropriation for. Resolved:** That there be, and hereby is, appropriated from the General Fund, the sum of \$55,982 for the purpose of matching federal funds allotted to Maine under the National Defense Education Act of 1958; and be it further

**Resolved:** That the above appropriation be apportioned to match federal allotments under specific titles of the National Defense Education Act of 1958 in accordance with the following schedule:
