**Chapter 1**

**AN ACT Relating to Appointment of Baxter State Park Agents and Representatives.**

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 36, § 43-A, additional. Chapter 36 of the Revised Statutes is amended by adding a new section 43-A, to read as follows:

'Sec. 43-A. Agents and representatives. The Baxter State Park Authority shall appoint agents or representatives to carry out sections 42 to 47. All appointed agents or representatives shall hold office under the rules of the Personnel Law. They shall be sworn to the faithful discharge of their duties and a certificate thereof shall be returned and filed in the office of the chairman of the authority. They shall receive such compensation for each and every day as determined by the authority, with approval of the State Personnel Board, with allowance for actual necessary expenses of travel.'

**Chapter 2**

**AN ACT Relating to Having Weapons in Motor Vehicles for Hunting.**

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 37, § 78, amended. The 4th sentence of section 78 of chapter 37 of the Revised Statutes, as revised, is amended to read as follows:

'No person, except a law enforcement officer in the line of duty or a person having a valid permit to carry a concealed weapon, may have in or on any motor vehicle or trailer any loaded pistol or revolver ~~with a barrel length of over 4 inches.~~'

### Chapter 3

AN ACT Relating to Penalty for Maliciously Injuring Domestic Animals.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 140, § 1, amended. Section 1 of chapter 140 of the Revised Statutes is amended to read as follows:

'Sec. 1. Maliciously killing or injuring domestic animals; stealing. Whoever willfully or maliciously kills, wounds, maims, disfigures or poisons any domestic animal or dog, or exposes any poisonous substance with intent that the life of such animal or dog shall be destroyed thereby, or steals or entices away or confines or harbors such animal for the purpose of obtaining a reward or for any other illegal purpose ~~shall be punished by a fine of not less than \$20 nor more than \$500, or by imprisonment for not more than 4 years~~ shall, when the offense is not of a high and aggravated nature, be punished by a fine of not more than \$300 or by imprisonment for not more than 3 months, or by both, and when the offense is of a high and aggravated nature by a fine of not more than \$1,000 or by imprisonment for not more than 4 years.'

### Chapter 4

AN ACT Relating to Operating Motor Vehicles on One-Way Roadways.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 22, § 115-A, additional. Chapter 22 of the Revised Statutes, as amended, is further amended by adding a new section to be numbered 115-A, to read as follows:

'Sec. 115-A. One-way roadways. Upon a roadway designated and sign-posted for one-way traffic a vehicle shall be driven only in the direction designated.'

### Chapter 5

AN ACT Relating to Notes Issued by School Administrative Districts.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 41, § 111-K, amended. The next to the last sentence of the first paragraph of section 111-K of chapter 41 of the Revised Statutes, as enacted
