## Chapter 50

AN ACT Relating to Closed Time on Deer in Long Island Plantation.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 37, § 91, amended. Section 91 of chapter 37 of the Revised Statutes, as revised, is amended by inserting before the 4th paragraph from the end a new paragraph to read as follows:

'There shall be a continual closed season on deer on the whole of Long Island in Long Island Plantation, Hancock County.'

## Chapter 51

AN ACT Relating to Unlawful Use of Motor Vehicle Operators' Licenses.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 22, § 159-A, additional. Chapter 22 of the Revised Statutes is amended by adding a new section 159-A, to read as follows:

'Sec. 159-A. Unlawful use of license. It is a misdemeanor for any person:

I. Display. To display or cause to be displayed or have in his possession any revoked, suspended, mutilated, fictitious or fraudulently altered operator's license;

II. Loan. To lend his operator's license to any other person or knowingly permit the use thereof by another;

III. Representation. To display or represent as one's own any operator's license not issued to him; or

IV. Use. To permit any unlawful use of an operator's license issued to him.'

## Chapter 52

AN ACT Relating to Registration of Saddle Mount Motor Vehicles.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 22, § 16, sub-§ III, amended. The 5th paragraph from the end of subsection III of section 16 of chapter 22 of the Revised Statutes, as amended by section 2 of chapter 308 of the public laws of 1957, is further amended to read as follows:

'Only one trailer or semi-trailer shall be drawn by a motor vehicle; provided that driveaway, towaway operations, as defined by the Public Utilities Commission, may include a combination of saddlemount vehicles not to exceed 3 units in contact with surface of the highway.'

## Chapter 53

AN ACT Relating to Prohibited Implements in Hunting Wild Birds or Animals.

*Be it enacted by the People of the State of Maine, as follows:*

Sec. 1. R. S., c. 37, § 86, amended. The first sentence of section 86 of chapter 37 of the Revised Statutes, as revised, is amended to read as follows:

'No person shall hunt with a net, trap, ~~crossbow~~ snare or contrivance other than the usual method of shooting with a firearm not larger than number 10-gauge or by shooting with a long bow and arrow, any wild bird or animal of any species protected by law.'

Sec. 2. R. S., c. 37, § 86, amended. Section 86 of chapter 37 of the Revised Statutes, as revised, is amended by adding after the first sentence a new sentence to read as follows:

'It shall be unlawful for any person to hunt or kill any wild bird or animal with a crossbow.'

## Chapter 54

AN ACT to Prohibit the Taking of Lobsters and Crabs During the Hours of Darkness.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 37-A, § 74, sub-§ II, additional. Section 74 of chapter 37-A of the Revised Statutes, as enacted by section 1 of chapter 331 of the public laws of 1959, is amended by adding a new subsection II, as follows:

II. Catching lobsters and crabs from tidal waters at night by any method unlawful. From June 1st to October 31st of each year, it is unlawful for any person to catch any lobsters or crabs from the tidal waters of the State by any method during the period  $\frac{1}{2}$  hour after sunset until  $\frac{1}{2}$  hour before sunrise of the following morning.'

Effective September 16, 1961
