CHAP. 54

PUBLIC LAWS, 1961

'Only one trailer or semi-trailer shall be drawn by a motor vehicle; provided that driveaway, towaway operations, as defined by the Public Utilities Commission, may include a combination of saddlemount vehicles not to exceed 3 units in contact with surface of the highway.'

Effective September 16, 1961

Chapter 53

AN ACT Relating to Prohibited Implements in Hunting Wild Birds or Animals.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 37, § 86, amended. The first sentence of section 86 of chapter 37 of the Revised Statutes, as revised, is amended to read as follows:

'No person shall hunt with a net, trap, erossbow snare or contrivance other than the usual method of shooting with a firearm not larger than number 10-gauge or by shooting with a long bow and arrow, any wild bird or animal of any species protected by law.'

Sec. 2. R. S., c. 37, § 86, amended. Section 86 of chapter 37 of the Revised Statutes, as revised, is amended by adding after the first sentence a new sentence to read as follows:

'It shall be unlawful for any person to hunt or kill any wild bird or animal with a crossbow.'

Chapter 54

AN ACT to Prohibit the Taking of Lobsters and Crabs During the Hours of Darkness.

Be it enacted by the People of the State of Maine, as follows:

- R. S., c. 37-A, § 74, sub-§ II, additional. Section 74 of chapter 37-A of the Revised Statutes, as enacted by section 1 of chapter 331 of the public laws of 1959, is amended by adding a new subsection II, as follows:
 - II. Catching lobsters and crabs from tidal waters at night by any method unlawful. From June 1st to October 31st of each year, it is unlawful for any person to catch any lobsters or crabs from the tidal waters of the State by any method during the period ½ hour after sunset until ½ hour before sunrise of the following morning.
