## PUBLIC LAWS, 1961

## CHAP. 106

national group, constituted to evaluate graduates from foreign medical schools, which is recognized by the ~~State of Maine~~ board of Registration in Medicine as competent to evaluate graduates from foreign medical schools, and who has served an internship for at least 12 months, or its equivalent, in a hospital approved by the American Hospital Association and the American Medical Association shall, upon the payment of a fee of ~~\$25~~ \$50, be entitled to examination and, if found qualified by a majority of the members of the board present, shall be registered as a physician or surgeon, and shall receive a certificate thereof under the seal of the board and signed by the chairman and secretary, which shall state the facts and must be publicly displayed at the person's principal place of business as long as said person continues such practice for gain or hire.'

Sec. 3. R. S., c. 66, § 4, amended. The next to the last sentence of section 4 of chapter 66 of the Revised Statutes is amended to read as follows:

'The board may in its discretion grant registration without examination to a physician in good standing who has been examined and licensed by a board of another state or who has been examined and certified by a national medical examining board, provided the examination passed by the applicant is deemed by the board to have been equivalent in all essentials to its own examination, and provided ~~that~~ such applicant has paid a fee of ~~\$50~~ \$100 and has satisfied the educational and other qualifications ~~hereinbefore~~ in this section provided.'

## Chapter 105

### AN ACT Relating to Operation of Vehicles Loaned by a Dealer or Holder of a Transit Registration Certificate.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 22, § 29, sub-§ II, amended. Subsection II of section 29 of chapter 22 of the Revised Statutes, as amended by section 8 of chapter 200 of the public laws of 1955, is further amended by adding at the end thereof the following sentence:

'The Secretary of State may in his discretion extend said period of 7 consecutive days to no more than 30 consecutive days whenever he feels the need for such extension is justified.'

## Chapter 106

### AN ACT Relating to Temporary Motor Vehicle Number Plates for Nonresident Members of Armed Services.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 22, § 31-A, amended. Section 31-A of chapter 22 of the Revised Statutes, as enacted by section 8 of chapter 76 of the public laws of 1957 and

amended by section 26 of chapter 429 of the public laws of 1957, is further amended by adding after the first sentence, a new sentence, as follows:

'If the purchaser of such motor vehicle or boat trailer is a nonresident member of the armed services, said purchaser may operate the same for a period not to exceed 20 consecutive days thereafter without payment of a regular fee.'

## Chapter 107

### AN ACT Relating to Chief Administrative Officer of Board of County Commissioners of Aroostook County.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 89, § 254, amended. That part of the 3rd paragraph of section 254 of chapter 89 of the Revised Statutes, as repealed and replaced by section 7 of chapter 372 of the public laws of 1959, which relates to the chairman of the county commissioners of Aroostook County, is amended to read as follows:

'county commissioners, \$1,250; ~~chairman~~, except that one member of the board, designated by the board as chief administrative officer, shall receive \$5,000;'

R. S., c. 89, § 108, amended. Section 108 of chapter 89 of the Revised Statutes is amended by adding at the end of the first paragraph the following sentence:

'Such record may be made by microfilm process.'
