CHAP, 197

#### Chapter 194

AN ACT Relating to Use of Artificial Lights for Lighting Game.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 37, § 97-A, additional. Chapter 37 of the Revised Statutes, as revised, is amended by adding a new section 97-A, to read as follows:

'Sec. 97-A. Use of artificial lights for lighting game. The use of artificial lights between ½ hour after sunset and ½ hour before sunrise to illuminate, jack, locate, attempt to locate or show up wild birds or animals shall be unlawful during open season on deer, except as provided in section 94, and section 113, subsection IV.'

Effective September 16, 1961

#### Chapter 195

AN ACT Relating to Open Season on Black Bass Fishing.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 37, § 44, sub-§ VI, additional. Section 44 of chapter 37 of the Revised Statutes, as revised, is amended by adding a new subsection VI to read as follows:

'VI. Black bass. In any waters where the bag limit on black bass has been removed by rule and regulation of the commissioner, the season on black bass and the method of fishing for them shall be the same as for trout and salmon.'

#### Chapter 196

AN ACT Repealing the Tri-State Authority for Collective Construction and Operation of Institutions in Maine, New Hampshire and Vermont.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 28, repealed. Chapter 28 of the Revised Statutes is repealed.

#### Chapter 197

AN ACT Providing for a Compact with New England States for Confinement,
Treatment and Rehabilitation of Offenders.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 27-C, additional. The Revised Statutes are amended by adding a new chapter to be numbered 27-C, to read as follows:
