PUBLIC LAWS, 1961

Sec. 11. R. S., c. 17, § 29, amended. The first sentence of section 29 of chapter 17 of the Revised Statutes is amended to read as follows:

'Every retailer shall keep records of his sales, and of his rentals charged for living quarters in hotels, rooming houses, tourist or trailer camps, the kind and form of which shall be adequate to enable the Tax Assessor to determine the tax liability.'

Sec. 12. Effective date. Rentals payable on and after June 1, 1960, pursuant to contracts entered into prior thereto, shall be subject to the tax imposed by this act.

Chapter 228

AN ACT Increasing Number of Medical Examiners in Washington County.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 89, § 243, amended. The 3rd sentence of section 243 of chapter 89 of the Revised Statutes, as last repealed and replaced by section 59 of chapter 378 of the public laws of 1959, is amended to read as follows:

'The number of medical examiners so to be appointed shall be as follows: For the Counties of Franklin, Knox, Piscataquis, Sagadahoc and Waldo, 2 each; for the Counties of Hancock, Lincoln, Oxford and Somerset and Washington, 3 each; for the Counties of Kennebec, Washington and York, 4 each; for the Counties of Androscoggin and Aroostook, 5 each; for the Counties of Cumberland and Penobscot, 7 each; and they shall be appointed with reference to territorial distribution.'

Chapter 229

AN ACT to Define Plumbing.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 25, § 179, sub-§ V, amended. Subsection V of section 179 of chapter 25 of the Revised Statutes is amended to read as follows:

'V. Plumbing. "Plumbing" is the art of installing in buildings the pipes, fixtures and other apparatus for bringing in the water supply and removing liquid and water-carried wastes, and shall include the necessary water piping and water connections to all types of heating apparatus using water.'
