Chapter 1

RESOLVE, Authorizing Forest Commissioner to Occupy Certain State Property.

Forest Commissioner authorized to occupy certain state property. Resolved: That the Forest Commissioner be authorized to move in and occupy, on a permanent basis, the unused state-owned buildings and parcel of land in the Town of Wells for purposes of a forest fire warden combination living and storehouse headquarters.

The premises are described in deed of warranty from William A. Goodwin to the Inhabitants of the State of Maine dated August 14, 1935 and recorded in the York County Registry of Deeds, Book 862, Page 104; and be it further

Resolves, 1957, c. 89, repealed. **Resolved**: That chapter 89 of the resolves of 1957 be, and is, repealed; and be it further

Resolves, 1959, c. 3, repealed. Resolved: That chapter 3 of the resolves of 1959 be, and is, repealed.

Chapter 2

RESOLVE, Authorizing the Department of Inland Fisheries and Game to Convey Certain Land in Town of Salem.

Department of Inland Fisheries and Game authorized to convey land. Resolved: That the Department of Inland Fisheries and Game be, and hereby is, authorized and directed to convey by quitclaim deed to the United States of America, through the Administrator of General Services, the interest of the State in a certain piece or parcel of land situated in the Town of Salem, County of Franklin, bounded and described as follows: Commencing at a stake on the northerly side of the bridge crossing Quick Stream, so called, on the discontinued town road at the thread of the current in said stream; thence north 1212 CHAP. 3

twenty-two degrees (22°) and fifteen minutes (15') west one hundred seventyfour (174) feet to a stake in the thread of the current of said stream about fifteen (15) feet northerly from a small island; thence north eighty-three degrees (83°) east one hundred fifty (150) feet to a stake; thence south thirty-six degrees (36°) and thirty minutes (30') east one hundred sixty-eight (168) feet to a stake; thence south seventy degrees (70°) and fifteen minutes (15') east crossing said discontinued town road two hundred ninety-eight and five-tenths (298.5) feet to a stake near the side of the road; thence south sixty-three degrees (63°) east four hundred (400) feet to a stake near the side of the road; thence south forty-five degrees (45°) and thirty minutes (30') east along the side of said discontinued town road seven hundred seventy-five (775) feet to a stake; thence south ninety degrees (90°) west one thousand three hundred fifteen (1315) feet to a stake set in the center of said Quick Stream; thence northerly following the thread of the current of said Quick Stream to the point of beginning.

Being the same premises conveyed to the grantor by the grantee, this deed dated October 22, 1954 and recorded in the Franklin County Registry of Deeds, Book 334, Page 148.

Chapter 3

RESOLVE, Authorizing the State Military Defense Commission to Convey Certain Land in Rockland.

State Military Defense Commission authorized to convey certain land. Resolved: That the State Military Defense Commission be, and is, authorized and directed to convey by quitclaim deed to the City of Rockland, Knox County, the interest of the State in a certain lot or parcel of land situated in said Rockland, bounded and described as follows:

Beginning on the south side of Holmes Street at an iron bolt marking the northeast corner of land now or formerly of Charles Kiff; thence easterly by said Holmes Street about 285 feet to the westerly line of the Maine Central Railroad right-of-way; thence southeasterly by said railroad right-of-way to the westerly line of Lovejoy Street; thence southerly by said Lovejoy Street about 45 feet to land now or formerly of Lovejoy; thence westerly by land now or formerly of Lovejoy about 500 feet to land now or formerly of C. C. Filmore; thence northerly by said Filmore lot 165 feet; thence westerly still by said Filmore lot 33 feet; thence northerly by said Filmore lot and land now or formerly of the aforesaid Charles Kiff 250 feet, more or less, to the place of beginning.

Being the same premises conveyed to the State of Maine by the Inhabitants of the City of Rockland by deed dated May 11, 1954, recorded in Knox County Registry of Deeds, Book 349, Page 88.
