RESOLVES, 1963

#### Chapter 35

RESOLVE, Regulating Fishing in First Chase Lake, Aroostook County.

First Chase Lake; fishing regulated. Resolved: That the Commissioner of Inland Fisheries and Game is authorized and directed to issue a rule and regulation opening First Chase Lake, in Township 14, Range 9, Aroostook County, to fly fishing only with a daily limit of 5 fish.

Effective September 21, 1963

#### Chapter 36

RESOLVE, Regulating Ice Fishing on Nezinscot River, Androscoggin County.

Nezinscot River; ice fishing regulated. Resolved: That the Commissioner of Inland Fisheries and Game be authorized and directed to issue a rule and regulation opening Nezinscot River, in the Town of Turner, Androscoggin County, to ice fishing from the time ice forms in the fall until March 31st under the general laws, from the Central Maine Power Company transmission line crossing said river approximately 500 yards below the junction with Martin Stream to the dam in Turner Village.

Effective September 21, 1963

### Chapter 37

RESOLVE, Regulating Fishing in Speck Pond, Grafton, Oxford County.

Fishing in Speck Pond, Grafton (TA No. 2), Oxford County; regulated. Resolved: That the Commissioner of Inland Fisheries and Game is authorized and directed to issue a rule and regulation prohibiting the use or possession of live fish as bait in Speck Pond, Grafton (TA No. 2), Oxford County.

### Chapter 38

RESOLVE, in Favor of Certain Inhabitants of Webster Plantation, Penobscot County.

Certain inhabitants of Webster Plantation; land deeded to. Resolved: That the Forest Commissioner deed certain portions of the public lot in Webster Plantation to the following:

#### Chapter 39

RESOLVE, Regulating Fishing in Chain of Ponds, Franklin County.

Fishing in Chain of Ponds regulated. Resolved: That the Commissioner of Inland Fisheries and Game is authorized and directed to issue a rule and regulation establishing a minimum length limit of 12 inches on salmon taken in Chain of Ponds, Chain of Ponds Township, T2, R6, Franklin County.

#### Chapter 40

RESOLVE, Authorizing Attorney General to Convey Certain Land in Southport to Izetta M. Pinkham.

Land conveyed to; Izetta M. Pinkham. Resolved: That the Attorney General be authorized and directed to execute and convey, by quitclaim deed, to Izetta M. Pinkham the interest of the State of Maine for the sum of \$50 in a certain piece or parcel of land, as follows:

A certain lot or parcel of land in Southport, County of Lincoln and State of Maine, bounded and described as follows:

Beginning at a stake in the edge of the woods on the east side line of land of heirs of William Gray, which stake marks the N. W. Corner of land of Charles Ayers; thence N. 12° E. by said Gray's east line about 150 rods; thence N. 54° E. about 39 rods to the town road; thence southerly by said road as the same runs, to said Ayers' northerly line of land this point being opposite a tree marked on the other side same road; thence about S. 73° W. 8 rods, more or less, to the point begun at, the Gray line.

Meaning and intending to convey the interest of Fred L. Douglass conveyed to him by John H. Blair in his deed dated November 11, 1922, recorded February 5, 1923, in Book 365, Page 240 in the Lincoln County Registry of Deeds, the said Fred L. Douglass having died October 31, 1958, at Windham, Maine, leaving no widower, widow or kindred.
