## Chapter 41

### RESOLVE, Regulating Fishing in Certain Waters of Somerset and Kennebec Counties.

**Fishing in certain waters in Somerset and Kennebec Counties; regulated. Resolved:** That the Commissioner of Inland Fisheries and Game is authorized and directed to issue a rule and regulation opening Fahi Pond, Embden, Somerset County; Hayden Lake (Wesserunsett Lake), Madison, Somerset County; North Pond, Mercer and Smithfield, Somerset County and Rome, Kennebec County; East Pond, Smithfield, Somerset County and Oakland, Kennebec County; Wyman Pond, Brighton, Somerset County, to fishing under the general laws for all fish except trout, salmon and togue from October 1st to October 31st of each year.

## Chapter 42

### RESOLVE, Authorizing Anthony M. Look and the A. M. Look Canning Company to Sue the State of Maine.

**Anthony M. Look and the A. M. Look Canning Company authorized to sue State of Maine. Resolved:** That Anthony M. Look and the A. M. Look Canning Company, of East Machias, County of Washington, State of Maine, which individual and company suffered damage to their property by the altering and changing of grade of Route 191 in said East Machias by the Highway Department of the State of Maine, are authorized to institute a civil action in the Superior Court of Washington County within one year from the effective date of this resolve, at any term thereof, against the State of Maine. The complaint and summons commencing the action authorized by this resolve shall be served on the Secretary of State by attested copy 20 days before the return day thereof by the sheriff or any of his deputies in any county of the State of Maine, and the conduct of said action shall be according to the practices of actions and proceedings between parties and suitors in said Superior Court; and the Attorney General is authorized and designated to appear and to answer said action to recover the damages sustained as aforesaid; and any judgment that may be recovered in such action shall be payable from the General Highway Fund by the State of Maine on final judgment rendered by said court; and costs may be taxed for said Anthony M. Look and the A. M. Look Canning Company if they recover in said action. Hearing thereon shall be before 3 Justices of the Superior Court, without a jury; said justices to be assigned by the Chief Justice of the Supreme Judicial Court of Maine.
