## Chapter 92

### RESOLVE, Appropriating Moneys for Support of the Civil Air Patrol Program.

Civil air patrol program; appropriation for. **Resolved:** That there be appropriated from the Unappropriated Surplus of the General Fund the sum of \$5,000 for the fiscal year ending June 30, 1964 and \$5,000 for the fiscal year ending June 30, 1965 to be paid to the Maine Wing, Civil Air Patrol to be expended as in its best judgment would most effectively carry out its purposes and objectives.

## Chapter 93

### RESOLVE, Providing for the Revision of the Statutes.

**Revision of Statutes Committee. Resolved:** That a joint committee of 2 members of the Senate to be appointed by the President of the Senate and 3 members of the House of Representatives, one of whom shall be a member of the minority party, to be appointed by the Speaker of the House, is created for the purpose of preparing and completing a revision of the statutes and public laws of the State. Said committee, with the assistance of the Director of Legislative Research, is authorized to consolidate all the public laws now in force and such as may be enacted at the present session of the Legislature; to omit from said revision all such statutes and acts as have been repealed or superseded; to arrange the chapters and sections of the revision so that relative subject matters will be contiguous as far as possible; to add annotations to all decisions interpreting the statutes and the Constitution of the State of Maine; to correct the notes and references for new sections; to prepare a cross reference table showing where the sections and chapters of the 1954 revision and laws amendatory thereof appear in the new revision; and to report a final draft of such revision in print. The committee is authorized in its discretion to omit chapter 162 of the present Revised Statutes, entitled "The Insolvent Law;" and be it further

**Resolved:** That the committee shall supplement the final draft herein provided for with a suitable, comprehensive index; and be it further

**Resolved:** That the committee shall cause not more than 300 copies of the revision to be printed and bound in paper or board covers, and a copy thereof shall be delivered to each member of the Legislature as soon as practical; and be it further

**Resolved:** That the committee is authorized to employ such assistance as may be necessary to expedite the revision and approve for payment the expense of any preliminary printing and such extra expense as may be incurred by the Director of Legislative Research in carrying out his duties under this resolve; and be it further

**Resolved:** That the committee, subject to the approval of the Governor and Council, provide by contract with some responsible person or persons, upon such terms and conditions as they deem necessary for the interests of the State, for the editing, printing and binding of the report of the Revision Committee, submitting the final draft of the revision, and for the printing, binding and publication, as soon as may be after the enactment thereof, of not more than 5,000 copies of the Revised Statutes with the Constitution of the State, the Constitution of the United States, the repealing act, the cross reference tables, and the index prepared under this resolve. Said Revised Statutes shall be bound in such style as to the size of volumes, page, width of margin, printing, paper and binding as may be approved by the Governor and Council; and be it further

**Resolved:** That the State Controller, upon approval of the Chairman of the Revision Committee, is authorized to cause payment to be made for the services and proper expenses of the committee, and also compensation for such professional, expert and clerical assistants as may be employed; and be it further

**Resolved:** That the sum of \$190,000 is appropriated from the Unappropriated Surplus of the General Fund for carrying out the purposes of this resolve, and the unexpended balance at the close of any fiscal year shall not lapse but shall remain a continuing carrying account until the purposes of this resolve have been completely carried out; and be it further

**Resolved:** That this resolve, pertaining solely to facilitating the performance of the business of the Legislature and of the committee thereof, shall take effect upon approval.

## Chapter 94

**RESOLVE, for Development of Revenue-Producing Park Facilities on Mt. Battie.**

**Revenue-producing park facilities on Mt. Battie; appropriation. Resolved:** That there is appropriated from the Unappropriated Surplus of the General Fund the sum of \$100,000 for the development of park facilities on Mt. Battie, in the Town of Camden, to be expended by and under the supervision of the State Park Commission with approval of the Governor and Council.

Any balance on June 30, 1964 shall be carried forward to the 1964-65 fiscal year, but any unencumbered balance shall lapse on June 30, 1965.
