Sec. 6-A. R. S., T. 5, § 121, amended. The 2nd paragraph of section 121 of Title 5 of the Revised Statutes is amended to read as follows:

'The Treasurer of State shall receive an annual salary of \$8,500 \$10,000. He shall receive no other fee, emolument or perquisite.'

(There is appropriated from the General Fund the sum of \$1,125 for the fiscal year ending June 30, 1966 and the sum of \$1,500 for the fiscal year ending June 30, 1967 to carry out the purposes of this section.)

Sec. 7. R. S., T. 12, § 501, amended. The last sentence of section 501 of Title 12 of the Revised Statutes is amended to read as follows:

'The commissioner (Forestry) shall receive an annual salary of \$12,250 \$13,000, of which amount \$8,167 \$8,667 shall be paid from funds raised and created by the tax assessed under section 1601.'

(There is appropriated from the General Fund the sum of \$190 for the fiscal year ending June 30, 1966 and the sum of \$250 for the fiscal year ending June 30, 1967 to carry out the purposes of this section.)

Sec. 8. R. S., T. 35, § 1, amended. The first sentence of the 2nd paragraph of section 1 of Title 35 of the Revised Statutes is amended to read as follows:

'The chairman (Public Utilities Commission) shall receive a salary of \$13,000 per year, and the other commissioners a salary of \$11,500 \$12,000 each per year.'

(There is appropriated from the General Fund the sum of \$750 for the fiscal year ending June 30, 1966 and the sum of \$1,000 for the fiscal year ending June 30, 1967 to carry out the purposes of this section.)

Sec. 9. Effective date. Sections 1, 2 and 3 of this Act shall become effective on the first Wednesday of January, 1967.

Sec. 10. Application. Notwithstanding Legislative Document 1590 of the 102nd Legislature, the words "General Fund" under this Act shall mean the General Fund and not the Unappropriated Surplus of the General Fund.

Chapter 413

AN ACT Providing for Adult Identification Cards Under Liquor Law.

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 28, § 1060, additional. Title 28 of the Revised Statutes is amended by adding a new section 1060, to read as follows:

'\$ 1060. Adult identification cards

Any resident of the State or nonresident in the State, between 21 and 25 years of age, may make application to the Liquor Commission for an adult identifica-

tion card upon a form provided by the commission. The commission, upon receipt of an application, accompanied by a photograph of the applicant and such supporting documents and information as it may require, shall issue an identification card to the applicant bearing his photograph, together with his name, address, date of birth and such other information and identification as it may deem necessary. The identification card issued under this section shall not be valid until signed by the applicant.

There shall be no fee for the issuance of an adult identification card.

Any person issued an identification card shall exhibit the same upon the demand of any licensee, his servant or agent, or any law enforcement officer in carrying out his duties relating to liquor, and his failure to produce the card upon the demand of any licensee shall entitle the licensee to refuse to sell alcoholic beverages to him.

Any person who misrepresents his age or practices any deceit in the procurement of an identification card, or has in his possession a false identification card, or uses or exhibits for the purpose of procuring alcoholic liquor, an identification card belonging to another, or which has been forged or altered, or any person who loans or transfers his identification card to another for use in the procurement of alcoholic beverages shall be guilty of a misdemeanor.

Any law enforcement officer who, in the performance of his duty, finds an identification card in the possession of a person other than the person to whom the same has been issued shall confiscate such card and return the same to the Liquor Commission.

The Liquor Commission shall have the power to adopt such rules and regulations as it shall deem necessary or advisable to effectuate the purposes of this section.'

Chapter 414

AN ACT Relating to Service Retirement of Liquor Inspectors.

Be it enacted by the People of the State of Maine, as follows:

- R. S., T. 5, § 1121, sub-§ 4, ¶ D, additional. Subsection 4 of section 1121 of Title 5 of the Revised Statutes is amended by adding a new paragraph D to read as follows:
 - 'D. Any member who is a liquor inspector, including the chief inspector, and in any case at least 25 years of creditable service in his respective capacity, may be retired on or after the attainment of age 55 years on a service retirement allowance, but must be retired at the attainment of age 65, which will be equal to $\frac{1}{2}$ of his average final compensation.'
