## Chapter 415

### AN ACT Providing for Penobscot County Funds for Buildings for Education Programs for Retarded Children.

*Be it enacted by the People of the State of Maine, as follows:*

**R. S., T. 20, § 3162, amended.** The last sentence of section 3162 of Title 20 of the Revised Statutes is amended to read as follows:

‘This section shall apply to Oxford County and Penobscot County only.’

Effective September 3, 1965

## Chapter 416

### AN ACT Increasing Salary of the Adjutant General.

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. R. S., T. 25, § 712, amended.** The 9th paragraph of section 712 of Title 25 of the Revised Statutes is amended to read as follows:

‘The Adjutant General shall receive an annual salary of ~~\$10,000~~ \$12,500. He shall receive no other fee, emolument or perquisite.’

**Sec. 2. Appropriation.** There is appropriated from the General Fund the sum of \$2,084 for the fiscal year ending June 30, 1966 and the sum of \$2,500 for the fiscal year ending June 30, 1967 to carry out the purposes of this Act.

## Chapter 417

### AN ACT Increasing Salaries of Members of Industrial Accident Commission.

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. R. S., T. 39, § 91, amended.** The first sentence of the 3rd paragraph of section 91 of Title 39 of the Revised Statutes is amended to read as follows:

‘The chairman (of the Industrial Accident Commission) shall receive a salary of ~~\$10,000~~ \$11,500 per year, and the other commissioners a salary of ~~\$9,000~~ \$10,000 each per year.’

**Sec. 2. Appropriation.** There is appropriated from the General Fund the sum of \$3,500 for the fiscal year ending June 30, 1966 and the sum of \$3,500 for the fiscal year ending June 30, 1967 to carry out the purposes of this Act.

**Sec. 3. Effective date.** It is the intention of the Legislature that this Act shall be retroactive to July 1, 1965.
