Any party may appeal from the decision of the Superior Court to the Supreme Judicial Court as in other civil cases.'

Sec. 2. R. S., T. 12, §§ 651-658, repealed. Sections 651 to 658 of Title 12 of the Revised Statutes are repealed.

Sec. 3. **Contingent upon authorization and ratification of bond issue.** This Act, with the exception of section 4, shall not become effective unless the Legislature adopting this Act shall have by legislation authorized a bond issue in the amount of \$1,500,000 to develop the maximum wilderness character of the Allagash Waterway, and unless and until the people of the State of Maine shall have ratified the issuance of bonds as set forth in such Act.

Sec. 4. **Appropriation.** There is appropriated from the General Fund to the Maine State Park and Recreation Commission the sum of \$65,250 and to the Department of Attorney General the sum of \$9,750 for the administration of this Act. The breakdown of expenditures shall be as follows:

## Chapter 497

**AN ACT** Relating to Credit for Military Service Under State Retirement Law.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., T. 5, § 1094, sub-§ 13, additional. Section 1094 of Title 5 of the Revised Statutes, as amended, is further amended by adding a new subsection 13, to read as follows:

'13. **Military service credit.** Anything to the contrary notwithstanding, military service shall be credited to all state employees who are unable to otherwise qualify for military service credits. A state employee shall be entitled to this credit only if at point of retirement he shall have at least 15 years of membership service in the State Retirement System. The member shall contribute to

the retirement system for each year of military service claimed 5% of the earnable compensation paid such member during the first year of state employment subsequent to service in the Armed Forces. Credit for military service under this subsection shall be limited to 4 years. Such credit shall be available to those persons who were separated under conditions other than dishonorable from the Armed Forces of the United States.

It is the intent that these provisions shall apply to all persons, active or retired, but that for those already retired the effective date of any adjustment shall be not earlier than that date on which such time or credit is certified to the Maine State Retirement System.'

## Chapter 498

### AN ACT Relating to Limited Electrician's Licenses and Funds for State Electrical Inspection.

*Be it enacted by the People of the State of Maine, as follows:*

Sec. 1. R. S., T. 32, § 1101, sub-§ 7, additional. Section 1101 of Title 32 of the Revised Statutes is amended by adding a new subsection 7, to read as follows:

'7. Limited license. A limited electrician's license to install and service the electrical work related to a specific type of electrically operated equipment or to specific electrical installations shall be granted to any person who has passed a satisfactory examination before the board. It shall specify the name of such person who shall be limited to engage in the occupation of installing and servicing the electrical work related to the type of equipment or to specific electrical installations only authorized by this license. The annual fee for a limited electrician's license shall be \$5.'

Sec. 2. R. S., T. 32, § 1104-A, additional. Title 32 of the Revised Statutes is amended by adding thereto a new section 1104-A, to read as follows:

'§ 1104-A. Funds for enforcement. The Insurance Commissioner is empowered to expend up to \$2,500 of the funds accrued to the board for the employment of one or more state fire inspectors, subject to the Personnel Law, to assist in the enforcement of this chapter and for the purchase of necessary electrical testing equipment. Such expenditures of accrued funds shall terminate upon the employment of one or more state electrical inspectors.'

Sec. 3. Limitation. Persons holding a limited electrician's license on or before September 3, 1965 shall be granted a limited electrician's license under section 1 of this Act without further examination.
