District shall pay the amount of the tax assessed under said section 355 against the taxable polls and estates within his said town to the treasurer of the district in 3 installments, the first on or before June 1st of the year in which said tax is so levied, the 2nd on or before September 1st of said year and the 3rd on or before December 31st of said year.

Chapter 83

AN ACT Relating to Compensation of Aldermen of City of Lewiston.

Be it enacted by the People of the State of Maine, as follows:

- P. & S. L., 1939, c. 8, Art. V, § 9, amended. Section 9 of Article V of chapter 8 of the private and special laws of 1939, as last amended by section 1 of chapter 141 of the private and special laws of 1959, is further amended to read as follows:
- 'Sec. 9. Compensation. The members of the board of aldermen shall receive as full compensation for the performance of their official duties as aldermen the sum of \$20 for each meeting of the city council which they shall attend provided that no aldermen shall be paid an amount in excess of \$700 \$1,000 for such attendance during any one fiscal year. Members of the board of aldermen when they shall convene for the purpose of constituting a board of examiners in insanity cases shall receive as full compensation for such duties the sum of \$700 for each meeting attended.'

Chapter 84

AN ACT Permitting Merger of Maine General Hospital with Maine Medical Center.

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. Merger. Maine General Hospital, a corporation incorporated under the provisions of private and special laws of 1868, chapter 573, is authorized to merge with Maine Medical Center, a Maine corporation located at Portland in accordance with the vote of the corporators of Maine General Hospital at its annual meeting on November 18, 1964. The merger shall be perfected under the Revised Statutes of 1964, Title 13, section 961.
- Sec. 2. Powers and duties. Upon such merger, Maine General Hospital as merged into Maine Medical Center shall thenceforth be possessed of all the powers, privileges and immunities and subject to all the duties and obligations conferred by the corporation law of this State on corporations without capital stock, and all provisions of private and special laws relating to Maine General Hospital inconsistent therewith are repealed.
- Sec. 3. Repealer. Upon such merger, sections 3 and 5 of private and special laws of 1868, chapter 573, private and special laws of 1870, chapter 342, private

and special laws of 1897, chapter 331, private and special laws of 1903, chapter 21 and public laws of 1921, chapter 94, are repealed.

Chapter 85

AN ACT to Extend the Charter of the R. and T. Cement Railroad Company.

Be it enacted by the People of the State of Maine, as follows:

Extension of powers. The charter of the R. and T. Cement Railroad Company, as granted by the private and special laws of 1959, chapter 88; and extended by the private and special laws of 1961, chapter 39; and further extended by the private and special laws of 1963, chapter 104; is further revived, renewed and extended for a period of 2 years.

Chapter 86

AN ACT Increasing the Compensation of the Trustees of the Portland Water District.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1907, c. 433, § 10, amended. The next to the last sentence of section 10 of chapter 433 of the private and special laws of 1907 is amended to read as follows:

'Each member shall receive in full compensation for his services an allowance of four hundred dollars \$800 per annum.'

Chapter 87

AN ACT Creating the Newport Water District.

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. Territorial limits; corporate name; purposes. Subject to the provisions of section 17 hereof, the inhabitants and territory of the Town of Newport in the County of Penobscot, shall constitute a body politic and corporate under the name of Newport Water District for the purpose of supplying said Town of Newport, and the inhabitants of said district, with pure water for domestic, sanitary, commercial and municipal purposes.
- Sec. 2. Source of supply. The said water district, for the purposes of its incorporation, is hereby authorized to take, collect, store, hold, divert, use, flow,
