Emergency clause. In view of the emergency cited in the preamble, this Act shall take effect when approved.

Effective June 4, 1965

Chapter 173

AN ACT Relating to Appropriation for Certain Legislative Documents.

Be it enacted by the People of the State of Maine, as follows:

Relating to appropriation for certain legislative documents. The words, "General Fund," in all bills before the 102nd Legislature in regular session, except appropriations for General Fund Bond retirement and interest, bills relating to state employees' pay (L. D. 239), uniform local effort for payment of school subsidies (L. D. 1041), current service appropriations for the biennium ending June 30, 1967 (L. D. 1354), supplemental appropriations for the biennium ending June 30, 1967 (L. D. 1524), and funds for accelerated program for the University of Maine (L. D. 1576), that appropriate money to finance the matters contained in the individual bills shall be construed to mean the Unappropriated Surplus of the General Fund.

Chapter 174

AN ACT Relating to Appropriation to Adjust State Employees' Pay.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Appropriation. There is appropriated from the General Fund the sum of 685,400 for the fiscal year ending June 30, 1966, and the sum of 1,370,800 for the fiscal year ending June 30, 1967, to effectuate as of the first pay period in January, 1966 a pay adjustment plan for state employees; such plan to be approved by the State Personnel Board. The above appropriated funds are for both classified and unclassified positions in the General Fund. Any balance at June 30, 1966 shall not lapse but shall carry forward into the 1966-67 fiscal year to be used for the same purpose. The breakdown shall be as follows:

Sec. 2. Unclassified employees subject to Governor and Council determination. With respect to unclassified employees whose wage rates are subject to Governor and Council determination, the Governor and Council are requested to consider such similar and equitable treatment as they may conclude is appropriate.

PRIVATE AND SPECIAL, 1965

Sec. 3. Unclassified employees not subject to Governor and Council determination. With respect to unclassified employees whose wage rates are not subject to determination by the Governor and Council, the authorities responsible for determining the wage rate of such employees are requested to consider such similar and equitable treatment as they may conclude is appropriate.

Sec. 4. Utilization by other funds. Wages of employees in departments supported by the Highway Fund, Special Revenue Funds or other funds shall not be adjusted from moneys provided for the General Fund Pay Plan, but may be adjusted from funds available to the department from other sources.

Sec. 5. Intent. It is the intent of the Legislature to adjust the ranges of the state salary schedule to reflect competitive wages now being paid by commerce and industry throughout the State of Maine.

Chapter 175

AN ACT Providing for New Ferry Landing at Forest City Landing, Peaks Island.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Construction. The Maine Port Authority is authorized and directed to construct a new ferry landing for the movement of vehicles at Forest City Landing, Peaks Island.

Sec. 2. Appropriation. There is appropriated from the Unappropriated Surplus of the General Fund to the Maine Port Authority the sum of \$70,000 for the fiscal year ending June 30, 1966 to carry out the purposes of this Act.

Sec. 3. Operational and maintenance costs. Annual rental shall be paid to the State of Maine. Operational and maintenance costs will be paid for under lease contract by Casco Bay Lines.

Effective September 3, 1965

Chapter 176

AN ACT Appropriating Moneys for Dredging Project at New Harbor.

Be it enacted by the People of the State of Maine, as follows:

Dredging project at New Harbor; appropriation. There is appropriated from the Unappropriated Surplus of the General Fund to the Town of Bristol the sum of \$4,000, to aid said town for a dredging project at New Harbor. Such appropriation shall not be available until a like amount has been appropriated by the Town of Bristol for the same purpose.
