Chapter 181

AN ACT Appropriating Funds to Aid in Dredging the Harbor at Owl's Head.

Be it enacted by the People of the State of Maine, as follows:

Dredging at Owl's Head; appropriation. There is appropriated from the Unappropriated Surplus of the General Fund to the Town of Owl's Head the sum of \$4,500 to aid the town to dredge the harbor at Owl's Head for the purpose of providing a safe harbor for lobster boats. Such appropriation shall not be available until the sum of \$4,500 has been appropriated by the Town of Owl's Head for the same purpose and the sum of \$145,000 has been appropriated by the Congress of the United States for the same purpose. Such appropriation shall not lapse until June 30, 1967.

Chapter 182

AN ACT Appropriating Money to Supplement Federal Vocational Funds for Area Education Programs for Apprentices and Other Adult Workers.

Be it enacted by the People of the State of Maine, as follows:

Department of Education; appropriation. There is appropriated to the Department of Education from the Unappropriated Surplus of the General Fund the sum of \$20,000 for the fiscal year ending June 30, 1966 and the sum of \$20,000 for the fiscal year ending June 30, 1967 to supplement present vocational funds for conducting related instruction for apprentices or classes of technical or related instruction for other adult workers. Rates of reimbursement, established by the State Board of Education, will reimburse local school units partially or in full for expenditures made on account of nonresident students. Funds will also be used, as needed, to match federal vocational funds in order that the state vocational-technical schools may conduct similar courses for apprentices and other adult workers.

Effective September 3, 1965

Chapter 183

AN ACT Reactivating the Governor's Committee on Children and Youth.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Governor's Committee on Children and Youth, reactivated. The Governor shall appoint a committee of 20 members consisting of one each from the House of Representatives, the Senate, the Departments of Education, Health and Welfare, Mental Health and Corrections, Labor and Industry and 14 representative citizens, 2 of whom shall be youths. The Governor shall designate the chairman.
