CHAP. 195

The inhabitants of said cities, towns and plantations shall vote by ballot on said question and shall indicate by a cross or check mark placed against the words "Yes" or "No" their opinion of the same. The ballots shall be received, sorted, counted and declared in open ward, town and plantation meetings, and return made to the office of the Secretary of State in the same manner as votes for Governor and Members of the Legislature, and the Governor and Council shall count the same, and if it shall appear that a majority of the inhabitants voting on the question are in favor of the Act, the Governor shall forthwith make known the fact by his proclamation, and the Act shall become effective in 30 days after the date of said proclamation.

Secretary of State shall prepare ballots. The Secretary of State shall prepare and furnish to the several cities, towns and plantations ballots and blank returns in conformity with the foregoing Act, accompanied by a copy thereof.

Chapter 194

AN ACT Appropriating Funds for Classroom Building at Erskine Academy.

Be it enacted by the People of the State of Maine, as follows:

Classroom building at Erskine Academy; appropriation. There is appropriated the sum of \$25,000 from the Unappropriated Surplus of the General Fund to be expended by Erskine Academy, China, Maine, for the purpose of aiding the construction of a classroom building.

Chapter 195

AN ACT Appropriating Funds to Aid in Dredging the Royal River and Basin.

Be it enacted by the People of the State of Maine, as follows:

Appropriating funds to aid in dredging of the Royal River and Basin. There is appropriated from the Unappropriated Surplus of the General Fund to the Town of Yarmouth the sum of \$30,000 to aid said town to dredge a channel 80' x 8' in the Royal River and Basin of 8 acres. Such appropriation shall not be available until the sum of \$58,000 has been appropriated by the Town of Yarmouth for the same purpose and the sum of \$200,000 shall have been made available by the United States under section 107 of the 1960 River and Harbor Act for the same purpose. Such appropriation shall not lapse until June 30, 1967.
