Chapter 233

AN ACT to Reconstitute School Administrative District No. 38.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. School Administrative District No. 38 reconstituted and established; validation of proceedings in member municipalities. The municipalities of Dixmont and Etna are constituted to be and to have been since April 26, 1965, a School Administrative District, known as School Administrative District No. 38, with all of the powers, privileges and franchises granted to School Administrative Districts according to the Revised Statutes of 1964, Title 20, sections 211 to 307. The proceedings taken in the town meetings held in the municipalities of Dixmont and Etna, wherein it was voted to join in the formation of a School Administrative District, are validated, confirmed and made effective.

Sec. 2. Validation of election and proceedings of school directors and action by officers and agents. The school directors of School Administrative District No. 38, selected in the said municipalities to serve as such, are declared to be and to have been duly elected and qualified for the respective terms for which each was elected, and all of the proceedings of the board of school directors of said district as said board was from time to time constituted and as shown by the records of said district and all of the action duly taken in accordance therewith by the officers and agents of said district with regard to the issuance of capital outlay bonds, or any borrowing in anticipation of the sale thereof, or the preparation, presentation and acceptance of any school budget or any borrowing for current operating expenses, are validated, confirmed and made effective.

Sec. 3. Amendments. Any amendments of, additions to or changes in said sections 211 to 307 which may hereafter be enacted shall, unless otherwise specifically provided therein, be deemed to apply to and to govern said School Administrative District No. 38.

Sec. 4. Saving clause. If any provision of this Act or the application thereof to any person or circumstances is held invalid, the remainder of the Act and the application of such provision to other persons or circumstances shall not be affected thereby.

Chapter 234

AN ACT to Provide Special Administrative Positions in the Department of Health and Welfare.

Be it enacted by the People of the State of Maine, as follows:

Chapter 235

AN ACT to Incorporate the Seal Cove Water District.

Emergency preamble. Whereas, there is an urgent need of improved fire protection and an increased supply of pure water for drinking, sanitary and other purposes in the Town of Tremont; and

Whereas, additional water supply sources must be developed and major alterations, improvements and extensions made to said water supply system; and

Whereas, properties, funds and grants are now available which may not be available if a district is not formed at once; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Territorial limits; name; purposes. The inhabitants of and territory within the Town of Tremont shall be and hereby are constituted a body politic and corporate by the name of "Seal Cove Water District" for the purpose of supplying the inhabitants of said district with pure water for domestic, sanitary, commercial and municipal purposes and for the extinguishment of fires.

Sec. 2. Source of supply. The said water district, for the purposes of its incorporation, is authorized to take, hold, collect, store, flow, use, detain and distribute to and in the Town of Tremont water from any surface or underground brook, stream, spring, vein of water or other water source in said Town of Tremont or from such other source of supply as is approved by the Department of Health and Welfare, and may purchase water for said purposes.

Sec. 3. May exercise eminent domain. The said district, for the purposes of its incorporation, is authorized to take and hold, as for public uses, by purchase or otherwise, including by right of eminent domain, in the Town of Tremont any lands or interests in land or water rights necessary for erecting and maintaining dams, for flowage, for power for pumping its water supply through its mains, for reservoirs, for preserving the purity of the water and watershed, for laying and maintaining aqueducts and other structures for taking,
