### Chapter 257

#### AN ACT Relating to Operation of Homemaker Service by Department of Health and Welfare.

*Be it enacted by the People of the State of Maine, as follows:*

**Sec. 1. Homemaker service.** Under the authority of the Revised Statutes of 1964, Title 22, section 8, as enacted by chapter 132 of the public laws of 1965, the department is authorized to establish and operate homemaker services in various areas and to make grants to assist in developing homemaker services by nonprofit agencies approved by the department. The department shall promulgate rules and regulations to establish the standards for approval of such agencies for receiving such grants.

**Sec. 2. Appropriation.** There is appropriated from the General Fund to the Department of Health and Welfare the sum of \$24,500 to carry out the purposes of this Act. The breakdown of expenditures shall be as follows:

### Chapter 258

#### AN ACT Appropriating Moneys for Reconstruction of Dismukes Hall, Maine Maritime Academy.

**Emergency preamble.** Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the 102nd Legislature in regular session appropriated \$265,000 for the reconstruction of Dismukes Hall, Maine Maritime Academy; and

Whereas, supplementary funds are vitally necessary to complete the project; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

*Be it enacted by the People of the State of Maine, as follows:*
