### Chapter 61

**RESOLVE, to Permit Howard G. Richardson, Readfield, Use of His Out-of-State Credits to Obtain a Retirement Allowance.**

**Howard G. Richardson use of his out-of-state credits. Resolved:** That the Maine State Retirement System is directed to permit Howard G. Richardson, Readfield, to apply for a retirement allowance and in the computation thereof shall include that out-of-state service for which he has paid contributions and for which he would be credited upon completion of 20 years of service within the State.

### Chapter 62

**RESOLVE, Appropriating Moneys for Search of Lost Persons in the Woodlands of the State.**

**Reimburse Department of Inland Fisheries and Game for money spent to find lost persons. Resolved:** That there be appropriated from the General Fund to the Department of Inland Fisheries and Game the sum of \$3,612.40 to reimburse the department for expenses incurred during the fiscal year ending June 30, 1964 for attempting to find lost persons in the woodlands of the State.

### Chapter 63

**RESOLVE, to Reimburse Town of Hanover for Aid Extended Floyd Merrill.**

**Town of Hanover; reimbursed. Resolved:** That there be appropriated from the Unappropriated Surplus of the General Fund the sum of \$300 to be paid to the Town of Hanover to reimburse the town for support of Floyd Merrill.

### Chapter 64

**RESOLVE, to Reimburse Hotel Rumford for Additional Payment for Hotel Liquor License.**

**Hotel Rumford; reimbursed. Resolved:** That there is appropriated the sum of \$300 from funds of the Liquor Commission to be paid to the Hotel Rumford,

Rumford, for additional payments made in 1963 and 1964 for a hotel liquor license, spirituous and vinous.

## Chapter 65

**RESOLVE, to Reimburse Hotel Harris, Rumford, for Additional Payment for Hotel Liquor License.**

**Hotel Harris; reimbursed. Resolved:** That there is appropriated the sum of \$300 from funds of the Liquor Commission to be paid to the Hotel Harris in Rumford for additional payments made in 1963 and 1964 for a hotel liquor license, spirituous and vinous.

## Chapter 66

**RESOLVE, in Favor of Town of Milo.**

**Town of Milo; reimbursed. Resolved:** That there is appropriated from the Unappropriated Surplus of the General Fund the sum of \$1,273.68 to be paid to the Town of Milo to reimburse the town for support and medical care furnished Sadie F. Angove.

## Chapter 67

**RESOLVE, Providing for Pension for Mrs. Mary Belanger of Caribou.**

**Mrs. Mary Belanger; state pension. Resolved:** That a pension of \$30 per month be, and is, granted to Mrs. Mary Belanger, of Caribou, to be paid monthly from the appropriation for special legislative pensions. Such pension shall begin on July 1, 1965 and continue until otherwise provided by the Legislature.

## Chapter 68

**RESOLVE, Granting World War I Bonus to Stanley D. Royles of Portland.**

**World War I bonus granted to Stanley D. Royles. Resolved:** That there is appropriated from the General Fund the sum of \$100 to be paid to Stanley D. Royles, of Portland, as his World War I bonus.
