PUBLIC LAWS, 1967

### Chapter 77

AN ACT Relating to Breaking and Entering Mobile Home or House and Camp Trailers.

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 17, § 2103, amended. Section 2103 of Title 17 of the Revised Statutes is amended to read as follows:

### § 2103. Larceny of dwelling house by night or breaking and entering

Whoever, without breaking, commits larceny in the nighttime in a dwelling house or building adjoining and occupied therewith, or breaks and enters any office, bank, shop, store, warehouse, barn, stable, house trailer, mobile home, inhabitable camp trailer, vessel, railroad car of any kind, courthouse, jail, meetinghouse, college, academy or other building for public use or in which valuable things are kept, and commits larceny therein, shall be punished by imprisonment for not more than 15 years; and when the offense is committed in the daytime, by a fine of not more than \$1,000 or by imprisonment for not more than 6 years.

### Chapter 78

AN ACT Repealing the Law Making Prescribing of Contraceptives a Crime.

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 17, § 53, repealed. Section 53 of Title 17 of the Revised Statutes is repealed.

### Chapter 79

AN ACT to Revise the Teacher Certification Laws.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., T. 20, § 58, additional. Title 20 of the Revised Statutes is amended by adding a new section 58, to read as follows:

#### § 58. Certification of teachers

The board shall, in accordance with such rules and regulations as it prescribes, authorize the certification of teachers and other professional personnel for service in any public school in the State, or in any nonpublic school which accepts public funds for tuition or is approved for attendance purposes under section
