## Chapter 255

### AN ACT Relating to Definition of Sporting Camp Under Fish and Game Laws.

*Be it enacted by the People of the State of Maine, as follows:*

**R. S., T. 12, § 2254, amended.** The first paragraph of section 2254 of Title 12 of the Revised Statutes, as revised, is amended to read as follows:

A sporting camp, under this section, shall include any camp, lodge or building or lumber camp, regularly or temporarily open for hunting and fishing parties as distinguished from private dwellings, and which are situated in any of the unorganized townships in the State.

Effective October 7, 1967

## Chapter 256

### AN ACT Providing Relocation Assistance by Municipalities.

*Be it enacted by the People of the State of Maine, as follows:*

**R. S., T. 30, § 5106, sub-§ 11, additional.** Section 5106 of Title 30 of the Revised Statutes, as amended by section 4 of chapter 203 and chapter 485, both of the public laws of 1965, is further amended by adding a new subsection 11, to read as follows:

**11. Relocation assistance.** Municipalities may provide funds for relocation assistance services and payments to individuals, families and businesses displaced as a result of acquisition of real property for a public purpose.

## Chapter 257

### AN ACT Relating to Payment of Fees to Secretary of State Resulting in Protest.

*Be it enacted by the People of the State of Maine, as follows:*

**R. S., T. 29, § 55-A, additional.** Title 29 of the Revised Statutes is amended by adding a new section 55-A, to read as follows:

#### § 55-A. Payment of fees resulting in protest

Whenever the payment of any fee, as required in this Title, results in a protest or is returned by the bank upon which it was drawn because of "Insufficient Funds," "Account Closed," "No Account" or any other similar reason, there shall be charged a service collection of \$2 plus the cost of collection.

Effective October 7, 1967
