Chapter 300

AN ACT Revising Names of Bureaus in Department of Agriculture.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., T. 7, § 3, amended. Section 3 of Title 7 of the Revised Statutes is amended to read as follows:

§ 3. Departmental divisions

The various bureaus and lines of work in the department shall be grouped into divisions, known as Divisions of Administration, Markets, **Agricultural Promotion**, Animal Industry, Plant Industry and ~~Inspection~~ **Consumer Protection**.

Sec. 2. R. S., T. 10, § 2401, amended. The 2nd sentence of section 2401 of Title 10 of the Revised Statutes is amended to read as follows:

The Chief of the Division of ~~Inspection~~ **Consumer Protection** of the Department of Agriculture shall be, *ex officio*, the state sealer.

Chapter 301

AN ACT Relating to Sprinkler Systems in Boarding Homes.

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 25, § 2452, amended. The first paragraph of section 2452 of Title 25 of the Revised Statutes is amended by adding at the end thereof the following:

Automatic sprinkler systems shall not be required in boarding homes prior to July 1, 1969.

Chapter 302

AN ACT Relating to Attending Secondary School Outside of Residence.

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 20, § 1291, amended. The 4th sentence of section 1291 of Title 20 of the Revised Statutes, as enacted by chapter 319 of the public laws of 1965, is amended to read as follows:

Any youth whose parent or guardian maintains a home for his family in an administrative unit that maintains, or contracts for school privileges in, an approved secondary school, and who has met the qualifications for admission to the high school in his town, may elect to attend some other approved

secondary school in the State to which he may gain admission for the purpose of studying or of completing at least a 2-year course in mathematics, science or a foreign language not offered or contracted for by the administrative unit of his legal residence, provided that tuition in such cases shall not be payable by the administrative unit where the pupil resides unless a pupil has applied for such course to the superintendent of schools of the unit wherein he has school residence on or before June 1st of a given year.

Chapter 303

AN ACT Relating to Functions of State Political Conventions.

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 21, § 402, sub-§ 4, repealed and replaced. Subsection 4 of section 402 of Title 21 of the Revised Statutes is repealed and the following enacted in place thereof:

4. Certain officers of state committee. The chairman, vice-chairman, treasurer and finance chairman may be chosen from outside its membership.

Chapter 304

AN ACT Reclassifying Certain Inland Waters of the State.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., T. 38, § 368, amended. That part of section 368 of Title 38 of the Revised Statutes which relates to waters captioned **Kennebec River, Cobbosseecontee Stream Drainage System**, is amended by adding a new subsection 2-A, to read as follows:

2-A. **Cobbosseecontee Stream, main stem, from its confluence with the Kennebec River to the dam at latitude 44°-13.3', longitude 69°-47.2' (approximately)**
—Class C.

Sec. 2. R. S., T. 38, § 368, amended. Subsection 13 of that part of section 368 of Title 38 of the Revised Statutes which relates to waters captioned **Kennebec River, Cobbosseecontee Stream Drainage System**, is amended to read as follows:

13. **Wilson Stream (Monmouth), main stem, from outlet of Wilson Pond to the junction with the branch of Wilson Stream entering from the vicinity of Monmouth Village below the tracks of the Maine Central Railroad—Class D C.**

Sec. 3. R. S., T. 38, § 368, amended. Subsection 4 of that part of section 368 of Title 38 of the Revised Statutes which relates to waters captioned **Kennebec River, Main Stem**, is amended to read as follows:
