## Chapter 354

### AN ACT Relating to Expenditure of Assessment for Fire Protection Tax in Certain Townships.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., T. 30, § 1201, amended. Section 1201 of Title 30 of the Revised Statutes is amended by adding at the end the following new paragraph:

All sums paid to counties by the State Tax Assessor under this section for fire protection shall be expended by the county commissioners exclusively for the purposes for which the assessments were made. Any county commissioner who willfully violates this paragraph shall be punished by a fine of not more than \$100.

Effective October 7, 1967

## Chapter 355

### AN ACT Relating to Transportation of Disabled, Collision Damaged, Wrecked or Repossessed Highway Motor Vehicles.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., T. 35, § 1560, sub-§ 1, ¶ K, additional. Subsection 1 of section 1560 of Title 35 of the Revised Statutes is amended by adding a new paragraph K, to read as follows:

K. While engaged exclusively in the transportation of disabled, collision damaged, wrecked or repossessed highway motor vehicles within 35 miles by highway from the carrier's regular place of business.

## Chapter 356

### AN ACT Authorizing Department of Health and Welfare to Make Grants to Municipalities.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., T. 22, § 10, additional. Title 22 of the Revised Statutes is amended by adding a new section 10, as follows:

#### § 10. Municipal grants

The department is authorized to make grants to cities or towns within the State, or to nonprofit corporations organized for purposes related to public health or welfare, out of federal funds when such grants are permitted by the
