Chapter 506

AN ACT Relating to Custody of Children Committed to a Center Under Department of Mental Health and Corrections.

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 15, § 2716, amended. The first paragraph of section 2716 of Title 15 of the Revised Statutes is amended by adding at the end 2 new sentences to read as follows:

When the custody, at the time of commitment, is in the Department of Health and Welfare, such custody shall be temporarily suspended while the child is in a center. Upon termination of custody of the child by the center, by discharge, the custody of the child shall revert to the Department of Health and Welfare if the child is still under 18 years of age.

Chapter 507

AN ACT Relating to Display of Buoy Colors on Boats.

Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after the adjournment of the Legislature unless enacted as emergencies; and

Whereas, the present law requires buoy colors to be displayed on boats used for lobster or crab fishing by either painting on such colors on the boats or using a plaque on the boats; and

Whereas, the following legislation is vitally necessary to prevent undue hardship on those of our Maine citizens who fish for lobsters or crabs; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine, and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

R. S., T. 12, § 4405, sub-§ 3, amended. Subsection 3 of section 4405 of Title 12 of the Revised Statutes, as enacted by section 1 of chapter 216 of the public laws of 1967, is amended by adding at the end, a new sentence, as follows:

Notwithstanding any other provision of this section, a person who fishes for lobsters or crabs may display his buoy colors as stated on his lobster and crab fishing license by mounting a buoy at least 12 inches in length with his color scheme thereon on said boat so that it will be clearly visible from each side.
